Sir,

In producing herewith the following seized live prohibited firecrackers as 1) 100 Packets Small fire cracker styled as "FATHER'S KING COBRA" (each packet containing 30 pcs where as total-  $100 \times 30 = 3000$  Pcs), 2) 102 packets Special Chocolate firecracker styled as "ROLEX" (each packets containing 12 pcs where as total  $102 \times 12 = 1224$  pcs) and 3) 05 packets of Multi Colour Shots firecracker styled as "ENCORE 30" under proper seizure list, to the effect on 04.11.2023 I along with C/571 Md. Hasib Khan and C/730 Somnath Biswas were performing day mobile duty as per order, vide Balarampur P.S GDE No- 151 and C.C. No- 4581/ 23 date- 04.11.2023 and in course of my day mobile duty, received credible source information at 12:05 hrs that a huge quantity of illegal firecracker stocked in the shop name and styled as "Binod Varieties Store" at Barabazar Road near Bus stand under Balarampur P.S. After receiving that information, I informed the matter to O/C Balarampur PS and as per his kind direction; myself along with force proceed to held raid at the above noted shop near Bus stand at about 12:45 hrs. I along with force held raid at the above noted shop and found that the above noted huge quantity of live prohibited firecrackers heaped inside the shop. Seeing the police party, owner of the said shop fled away from the back side door of the shop and on search found huge quantity of firecrackers (Not green firecrackers). I along with force awaited sometimes but neither anybody appear before me nor produce any valid License or any valid documents in respect of live prohibited firecrackers in that shop. So it is strongly believed that the owner of the shop styled as "Binod Varieties Store" negligently deals with the live prohibited firecrackers which is dangers to human life and property. Hence I seized all those above noted live prohibited firecrackers under proper seizure list in presence of witnesses duly signed by them and also labeled the same. As the accused person fled away to avoid the touch of Police so it seemed that accused person having knowledge that those articles is dangerous to human life and property and not salable without valid license and precaution.

The accused has committed offence U/S- 188/286 IPC & 24 of the West Bengal Fire Services Act 1950, for negligently keeping live prohibited fire crackers in his shop without any valid license, which are endanger to human life and property.

Therefore I pray before you that a specific case may kindly be started against owner of the shop styled as "Binod Varieties Store" under section 188/286 IPC & 24 of the West Bengal Fire Services Act 1950 and arrange for its investigation.
