Sub: Complaint against Situ Tudu (52 yrs) S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S-Balarampur, Dist-Purulia to start a cog case U/S- 46 (A)(A) of B.E. Act. 1909.

Respected Sir,

In producing here with one arrested accused person namely Situ Tudu (52 yrs) S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S- Balarampur, Dist- Purulia along with following seized articles viz-

- 20 Ltrs (Approx) of ID liquor contained in a Plastic container (Jarican).
- 2) 250 grms (Approx) NISHADAL.
- Two pieces of plastic Jar.

I ASI Dulal Singh Saradri of Balarampur P.S do here by lodged a complaint against accused persons namely 1) Situ Tudu (52 yrs) S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S- Balarampur, Dist- Purulia to the effect that today on 17.11.2023 I ASI Dulal Singh Sardar along with C/1424 BHairab Patra & C/105 Surajit Biswas (SAP 11th Bn.) was engaged in evening mobile duty vide CC No-4819/2023 dt-17.11.2023. In course of mobile duty at about 17:05 hrs I received a telephonic information from a reliable source that one person have stocked some illicit liquor at his own house at Namsole (Aguibera) village under Balarampur P.S & selling the same to innocent people for their personal gain. Accordingly I informed the matter to O/C Balarampur PS & as per his order I along with force held raid at the namsole (Aguibera) village (as shown by source) and found that one person was mixing the ID liquor contained in 20 ltr. container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, in his own house at Namsole (Aguibera) village, Accordingly I detained one person who recognized him selves as Situ Tudu (52 yrs) S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S-Balarampur, Dist- Purulia. Being interrogated he confessed that the white powder like substance is NISHADAL, an intoxicated substance having acrid smell which is likely to cause disability or death to human being. It is also revealed during interrogation that above noted person was selling the illicit liquor mixing with NISHADAL with a view to cause physical disability or death to human being. So, I arrested the above mentioned accused person namely Situ Tudu S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S- Balarampur, Dist- Purulia maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused persons and available witnesses. Sample ID liquor approx 300 MI was taken in a plastic bottle from the seized Plastic container (Jarican).

Hence, I, therefore pray that a specific case may kindly be started under proper section of law against arrested accused persons namely Situ Tudu (52 yrs) S/O- Lt. Gera Tudu of Vill- Namsole (Aguibera), P.S- Balarampur, Dist- Purulia and arrange for its investigation.
