After that he went to the river side as ~~usual~~ ^{usual} at 5 p.m. on 17th Nov. 2023. till now he did not return to the home.

My son was 15 years old, 4'11" tall and thin with light fair body colour and has straight hair on his head, wearing check white-yellow t-shirt and black track pant and slipper

we checked all his friends home, relatives home as well as other possible places but were unable to trace him. The our family members now in very difficult situation because we don't know where he is now.
