On 03/11/2023 about 11:25 am, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Sri Maruti Mahato, Jr Engineer, Bundwan CCC, WBSEDCL and Sri Anindya Sundar Paul, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Arjun Murmu, S/o – Bihari Murmu, Vill-Keshra, PS – Bandwan, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of METER BYPASS.

From the above arrangement he was using the following electrical equipment's:

- 1) Fan – 1 Nos
- 2) Bulb – 2 Nos

Out of which I seized the following:

- 1) Service wire (6 mtr approx).

Seizure list was prepared at the site and accused person refused to sign.

The inspection team left the premises at 12:05 pm on 03/11/2023.

The accused person has committed an offence U/S 135/1/b of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.
