Due to the accident 1 Nos of Low Tension Pole with AB Cable was damaged by a vehicle no- DD 01M 9483 by colliding through that pole and AB Cable for rough driving. Name of the driver of the vehicle Brijendra Kori, S/O- Ramdhari Kori, village & PO- Jhokho Sidhi, MP-486661 and the owner of the vehicle Suresh Bhimrao Pukale, S/O-Bhimrao Pukale, House No- 1204, Sahajanand Society Dadra & Nagar Haveli, UT of DNH and Dadra & Nagar, Haveli- 396230. Due to damage of pole and the Low Tension over head AB cable line snapped down and power supply to 54 nos. consumers got hampered. For such WBSEDCL loss of property of Rs. 77398.00 (Seventy seven Thousand Three Hundred and Ninety Eight Only).

Hence you are requested to take legal steps in this regards in order to recover the cost of damage property of WBSEDCL.
