Sir,

In producing here with 01 (one) arrested accused person namely Khokan Tudu (35 Y) S/O-Lt. Bangshi Tudu of Vill- Bhogidih, P.O- Chirudih-Radhanagar, PS- Bandwan, Dist- Purulia along with seized motor Cycle under proper seizure list, arrest memo & other relevant papers.

I beg to state that today (23.11.23), in course of my mobile duty (vide Bandwan PS GDE No- 768, dtd 23.11.23) while I had been to Chandra More at about 12:15 hrs found that the one person in his Motor Cycle (Hero Passion i3S) having number plate-JH05CX1344 were coming from Bandwan side at a high speed. Myself along with force tried to stop him to avoid any untoward accident but the driver of the motorcycle drove speedily and disobediently and crossed us with rash and negligent driving. We could be able to detain him at Dhabani naka point on Bandwan-Katin road under Bandwan PS area after a hot chasing. This rough and negligent driving would lead to an accident at any time. Being asked the above accused person could not be able to give any satisfactory answer for such driving.

So I arrested him for rash and negligent driving which may lead to endanger human life at 12:45 hrs. I Issued memo of arrest as per his disclosed identity as noted above. I informed him regarding the ground of arrest and arranged for informing his relatives. He was driving the motor cycle on public way in rash and negligently as to endanger human life. On being asked he did not produce either any valid documents in respect of said motor cycle and driving licence in favour of the driver himself. Through the E-POS machine of Bandwan PS it is learnt that the owner of the said vehicle is arrested accused person Khokan Tudu (35 Y) S/O-Lt. Bangshi Tudu of Vill- Bhogidih, P.O- Chirudih-Radhanagar, PS- Bandwan, Dist- Purulia.

So I seized Motor Cycle bearing number plate- JH05CX1344 (Hero Passion i3S) after preparing proper seizure list duly signed by the accused person and police witnesses as there was no public witness in between 13:05 hrs to 13:15 hrs. I brought him to PS and put in lock up maintaining all hazat rules and informed table duty officer of the PS.

So I therefore pray before your good office that a specific case may be initiated against him as he committed offence U/S- 279 IPC & 181/184 MV Act. and arrange for its investigation.
