Dear Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to affect that Bhabatosh Mahato, S/o – Haripada Mahato, resident of village – Rajgram, PS – Bandwan, Dist – Purulia has committed theft of electricity U/S **135/1/a** of The Indian Electricity Act, 2003.

On 28/11/2023 about 15:45 hrs I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Sri Maruti Mahato Jr Engineer, Bundwan CCC, WBSEDCL and Sri Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Bhabatosh Mahato, S/o – Haripada Mahato at village – Rajgram, PS – Bandwan, Dist – Purulia by serving notice in presence of Sri. Ram Prashad Hansda (neighbor) and inspected his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of **TAPPING OF SERVICE WIRE.**

From the above arrangement he was using the following electrical equipment's:

- 1) Fan – 3 Nos, 2) Bulb – 2 Nos, 3) Tube Light – 1 Nos, 4) Weight machine – 1 Nos.

Out of which I seized the following:

- 1) Service wire (4 mtr approx).

Seizure list was prepared at the site and accused person refused to sign.

The inspection team left the premises at 16:20 hrs on 28/11/2023.

The accused person has committed an offence U/S **135/1/a** of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
