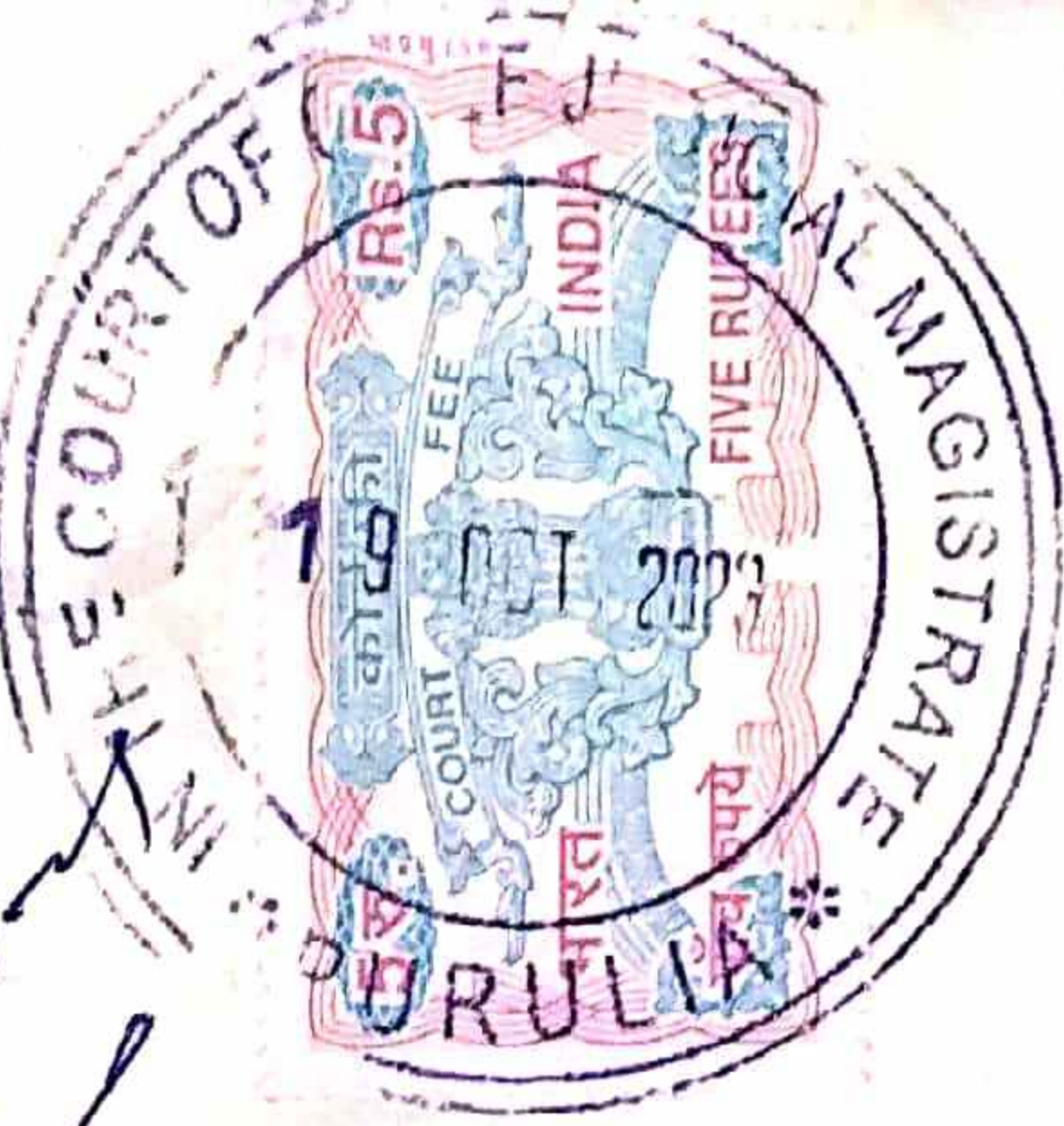

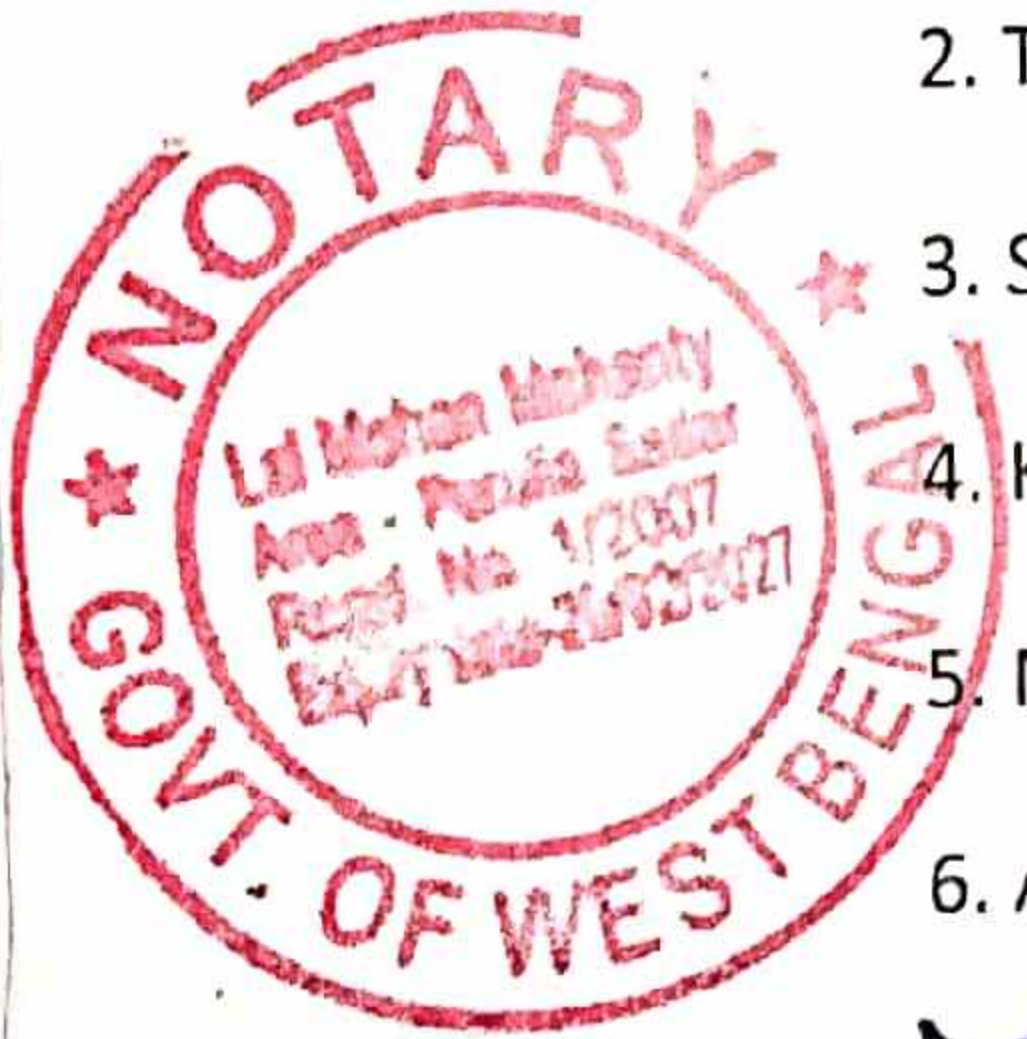

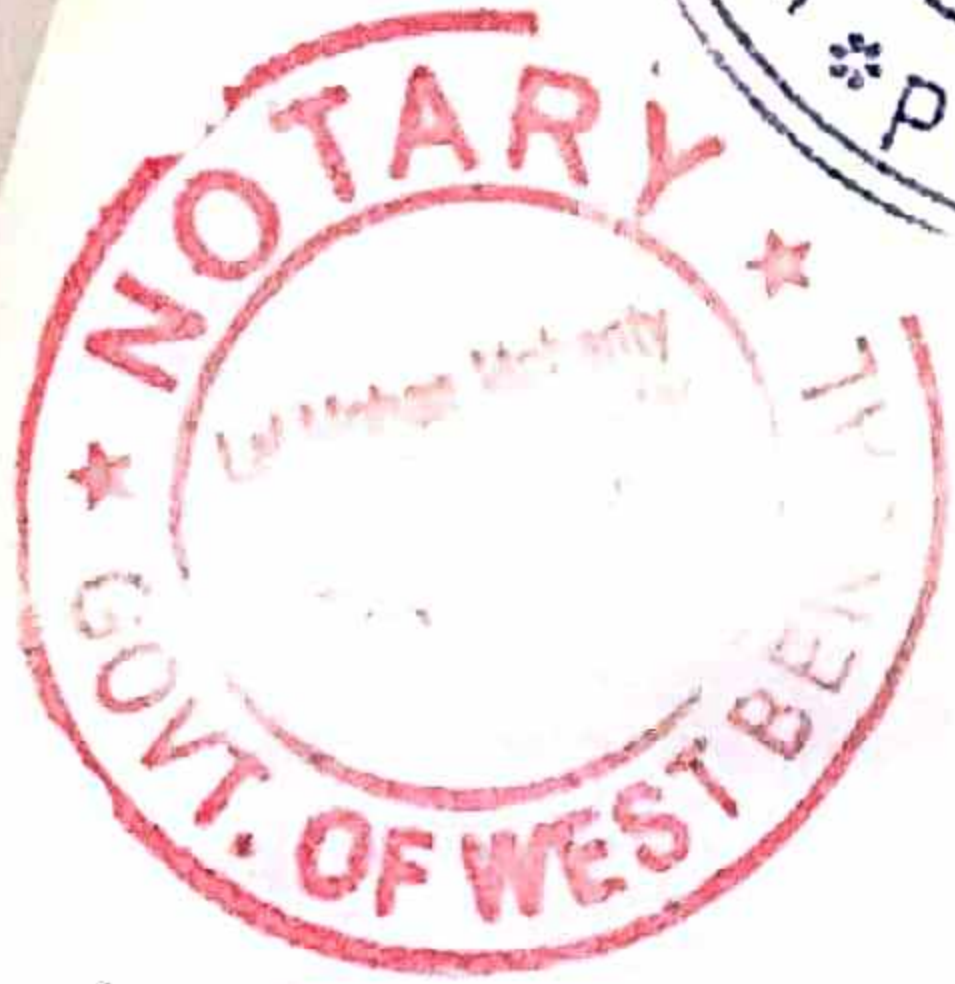

Plot no 293 in mouza Durku by removing the fence of Bamboo poles and plucked off the Brinjal Plants which were grown by the complainant by his own labour money and cost and put the complainant in loss with criminal intent and the accused persons forcefully took away the Bamboo poles and sticks to their houses from the said land of the complainant and on protest by the complainant the accused persons over powered the complainant and physically assaulted the complainant by feasts and blows , fell him down on the ground and thereby the complainant sustained pain injury over various parts of his body , thethereby the witnessesses came to the spot and resqued the complainant . the accused persons threatened the complainant with dire consequences .

Purulia on 10/10/23 but no action has been taken against the accused persons till now , hence the complainant has been compelled to file this petition before the Id. Court today

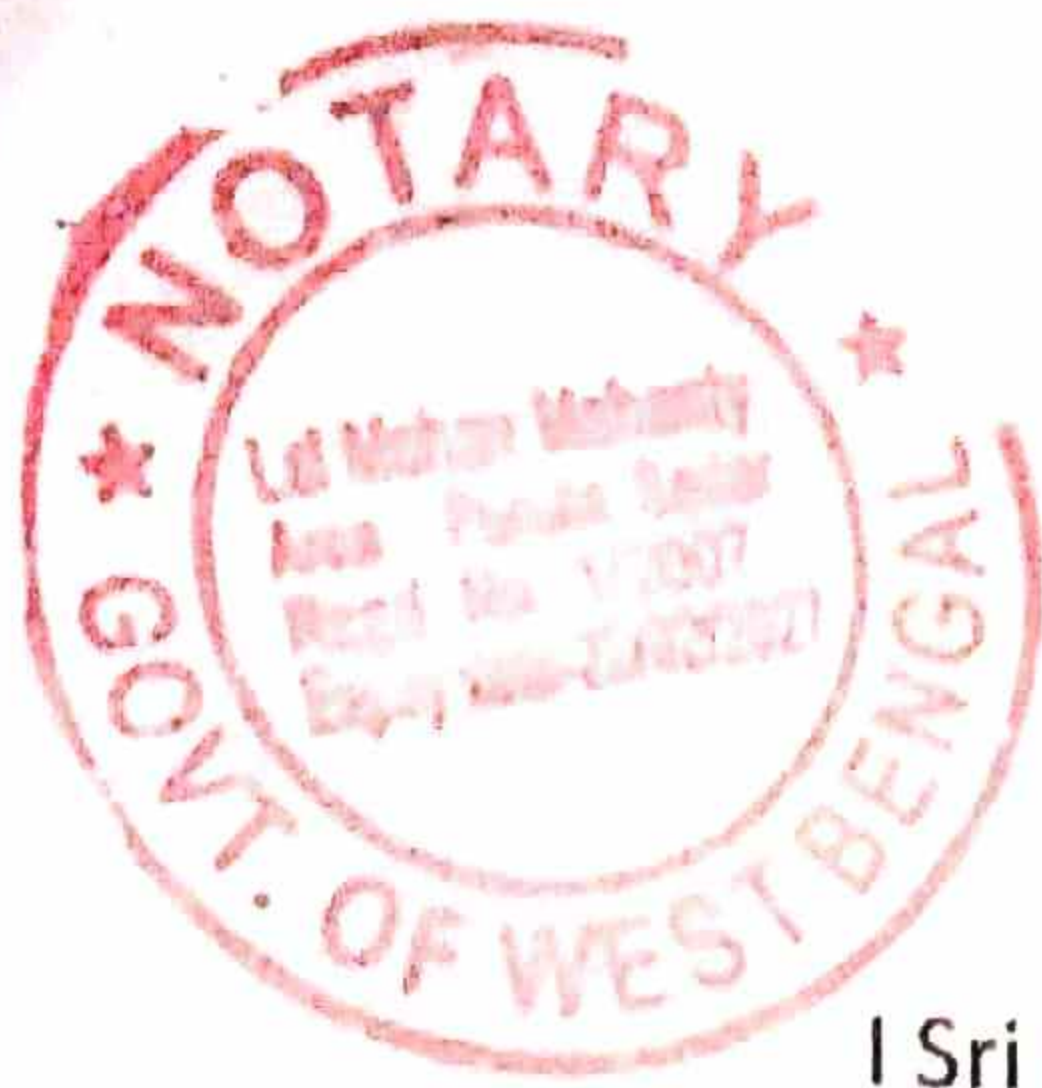

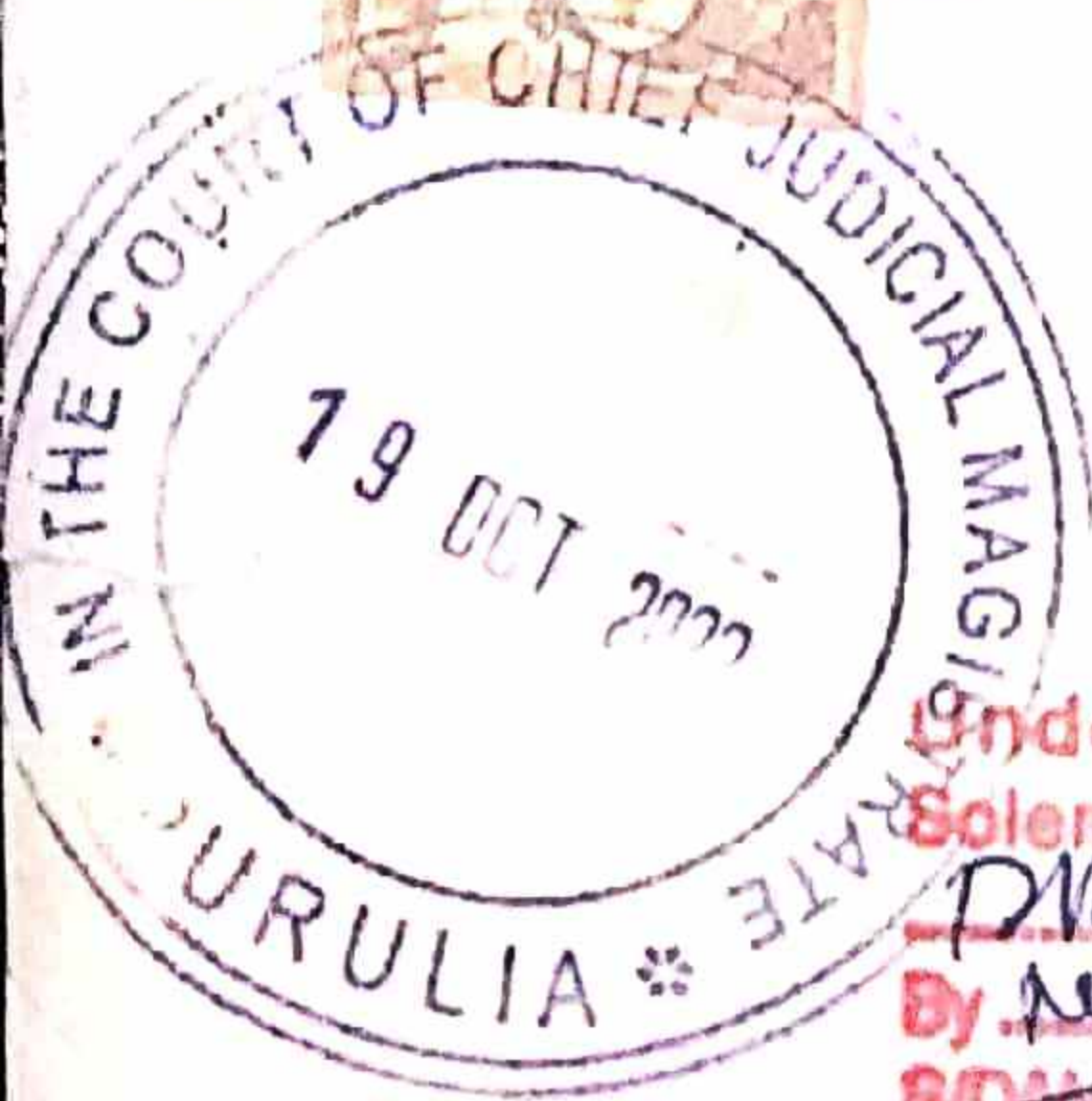
