Fact of the case in brief:-

Received on 05.11.2023 at 15.25 hours and Started Barchazar PS exervo-170/23 Later 5-11,23 US 341/447/427/379/506/34 1PC

First on 03/10/2023 at about 8.00 A.M. the accused persons most iullegally forming an unlawful assembly being armed with deadly weapons like Tangi , Kurul , lathi etc . forcefully trespassed into the cultivated land of the complainant over R.S. Plot no 293 in mouza Durku by removing the fence of Bamboo poles and plucked off the Brinjal Plants which were grown by the complainant by his own labour money and cost and put the complainant in loss with criminal intent and the accused persons forcefully took away the Bamboo poles and sticks to their houses from the said land of the complainant and on protest by the complainant the accused persons over powered the complainant and physically assaulted the complainant by feasts and blows , fell him down on the ground and thereby the complainant sustained pain injury over various parts of his body , thethereby the witnessesses came to the spot and resqued the complainant . the accused persons threatened the complainant with dire consequences .

2. That the complainant informed the incident before the police Barabazar P.S. verbally and by wiring through registered post on 05/10/2023 but no action was taken by the police, the complainant was firstly treated by the docor at Barabazar B.P.H.C. and was referred to Purulia Govt. Medical College & Hospital for further treatment and the complainant had to inform the matter to the S.P. Purulia on 10/10/23 but no action has been taken against the accused persons till now, hence the complainant has been compelled to file this petition before the ld. Court today

It is prayed therefore that your honour would be graciously pleased to sent this application to the I.C. Barabazar I'.S treating the same as an F.I.R. as provided U/S 156 (3) Cr.P.C. for investigation with a direction to start a case against the accused persons

after hearing be further be pleased to convict the accused persons for the offences committed by them


