I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 to the effect that RUPALI GORAIN W/O LATE SADHAN GORAIN of Vill- SNDRI, P.S- Barabazar , Dist- Purulia, has committed theft of electricity U/S 135(1)/e of electricity act 2003 subsequently amendment act 2007.

On 06.11.2023 at about 12.20 P.M. I Sri Banti Karmakar, AE & Station Manager, Barabazar CCC along with 01. Shibaji Chakraborty, JE(E) GR-II, Barabazar CCC, 02. Sanjit Mahato ,Sr. TSH, Barabazar CCC entered at domestic building site of RUPALI GORAIN W/O LATE SADHAN GORAIN of Vill- SNDRI, P.S- Barabazar , Dist- Purulia and found Rupali Gorain, was supplying the electricity from her existing meter (DDG347341)(Which is Defective) unauthorizely to another place with the help of 6 Sq. mm two core PVC Cable by unauthorized supply of electricity from her domestic premise and connected load found is 0.3 KVA. As that of RUPALI GORAIN W/O LATE SADHAN GORAIN of Vill- SNDRI committed theft of electric power. So, I partly Seized the following articles after preparing the seizer list in presence of 01. Shibaji Chakraborty, J.E GR II, BARABAZAR CCC, 02. Sanjit Mahato, Sr. TSH Barabazar CCC. The inspection team left the premises at 12:35 P.M


