Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that the below mentioned accused has committed interference with meter or work of licensee U/S 138 1/b of the electricity Act 2003, Amendment of 2007 as stated here under.

Today i.e 09.11.2023 I, Sri Banti Karmakar A.E & S.M along with Anup Mandi, SE(E), Prosenjit Chakraborty, JE(C), Gr-1, Sri Shibaji Chakraborty, JE(E) GR-II, Barabazar & Sanjit Mahato, Sr. TSH, Barabazar CCC, WBSEDCL went to make an inspection to workout upon a source information regarding unauthorized reconnection of a service connection bearing consumer id no. 200275970 in the name of KUKRA SING SARDAR village of TENTLO Dist- Purulia . The service connection was disconnected by WBSEDCL on 13.05.2015 due to non-payment of outstanding bill. The outstanding is Rs. 210.66 excluding applicable late payment surcharge as per regulation. The service connection is in deemed disconnected status in our database.

During the time of inspection at the domestic premises 1 nos. of electricity meter was found having serial no. T2071288 (Consumer Id: 200275970, Consumer Name- KUKRA SING SARDAR). The meter was connected to the mains through a service cable. The user KUKRA SING SARDAR was enjoying electricity service and reading on the meter was recorded No Display.

In present of the inspection team at about 3:00 pm entered to the premises and observed that user KUKRA SING SARDAR was using electricity whimsically re-connecting the service line bearing consumer id no.- 200275970 and has made offence under section 138(1)(b). Accused has made huge financial loss to WBSEDCL.

After detection to unauthorized reconnection of service line illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team.

The inspection team left the premises at about 3:15 pm.

The accused KUKRA SING SARDAR vill- Tentlo P.S-Barabazar has committed interference with meter or work of licensee under section 138(1)(b) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
