

Sub: Complaint against Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Kalindi of Village- Sukurhutu, PS-Barabazar, Dist-Purulia to start a specific case under proper section of Law.

In producing here with arrested accused person namely Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Sir, Kalindi of Village- Sukurhutu, PS- Barabazar, Dist- Purulia and seized (i) One white colour plastic jarakin containing with approx 17 (Seventeen) liters I.D liquors (Cholai) from which 500 ml seized as sample from said jarakin a separate plastic bottle as per enclosed seizure list.

I, PSI Aloke Rana of Barabazar PS do here by lodge this complaint against one Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Kalindi of Village- Sukurhutu, PS- Barabazar, Dist- Purulia. I beg to state that on 13.11.2023 myself along with C/- 1211Chunaram Hembram& C/- 2072Md. Kutubuddin Khan were left for mobile duty vide Barabazar PS GDE No- 664 Dtd. 13.11.2023. During mobile duty at about 19.45 hrs I received an information that one person was selling I.D liquor in his house at Sukurhutu village under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information.

At about 20.25 hrs myself along with force held raid in the dwelling house of Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Kalindi of Village- Sukurhutu, PS- Barabazar, Dist- Purulia and found that he was keeping &selling ID Liquor (Cholai) from his house. Seeing the Police party buyers fled away but somehow, we apprehended the alleged person who was keeping &selling ID Liquor (Cholai). On search I found (i) One white colour plastic jarakine containing approx 17 (Seventeen) liters I.D liquors (Cholai). On interrogation said Jadab Kalindi confessed his guilt and stated that he selling the I.D liquor (Cholai) to the local people with intent to make his own profit. He also admitted that he has no license or any authorization for keeping or selling of I.D liquor (Cholai) and he disclosed his identity as noted above.

Accordingly, I seized the same after preparing proper seizure list and put label on the seized article in presence of witnesses and from which 500 ml of I.D liquor taken as sample in a separate plastic bottle which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also.

I try to find out local witnesses but no one turn up before me. The seizure and label was done in

between 20.25 to 20.45 Hrs.

Thereafter, I arrested the accused person namely Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Kalindi of Village- Sukurhutu, PS- Barabazar, Dist- Puruliaafter preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest. The arrest was made on 13.11.2023 at 20.45 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Jadab Kalindi (Male/ 24 Yrs.) S/O- Manohar Kalindi of Village- Sukurhutu, PS- Barabazar, Dist- Purulia under proper section of Law.
