Subject: Complaint against Dipak Mahato (31 Yrs), S/O- Dubraj Mahato of Vill-Jargoria, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Dipak Mahato (31 Yrs), S/O- Dubraj Mahato of Vill-Jargoria, PS - Boro, Dist - Purulia with seized 10 (Ten) sealed bottles in containing 600 ml each bottles styled as 'DIL KHUSH' and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (11.11.2023) during my Spl. mobile duty in between 19:35 hrs to 19.45 hrs acting on a secret source information I apprehended the above noted person in his house at Jargoria village and found that above noted person illegally stocked and selling 'DIL KHUSH' to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly, I seized 10 (Ten) sealed bottles in containing 600 ml each bottles styled as 'DIL KHUSH' and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19.55 hrs u/s 46 A (C) B.E and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized 'DIL KHUSH' country spirit 600 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Dipak Mahato (31 Yrs), S/O- Dubraj Mahato of Vill-Jargoria, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/ 281 Avijit Patra, (2) C/ 793 Prasanta Kumar Patra accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Dipak Mahato (31 Yrs), S/O- Dubraj Mahato of Vill-Jargoria, PS - Boro, Dist - Purulia.
