Complainant above named beg to state as follows:

- 1) That, the Complainant and his brother Rahini Kanta Mandal are the recorded owner of R.S. Plot No. 1829 of Mouza Tilabani having an area 1 Acre 51 decimals, and the Complainant proposed to sale 6 decimals of land each having 50,000/- (Fifty thousand only) per decimals to the Accused Persons No.1 to 3, and the Complainant took as advance sum of Rs.15,000/- (Rupees fifteen thousand only) but the Accused

Persons have purchased 4 decimals of land by Registered Deed from Complainant but after execution and registration of Deed the Accused Persons No.1 to 3 did not pay any consideration of money to the Complainant and they deferred the matter on some pretext or otherwise.

Be it mentioned here, that a agreement was prepared on 13.09.2022 in presence of Falguni Singh and Kasem Ansary and they also put their respective signature and LTI. Several times Complainant requested to the Accused Persons to give his money but they openly given out threats to the Complainant if the Complainant further request for consideration of money then they will murder to the Complainant at any point of time.

- 2) That, the Complainant come to learn from reliable source that Accused Persons written in the said deed having 6 decimals of land in collusion with Deed Writer and the Complainant requested the Accused Persons to supply a copy of Deed but they are denied so the Complainant do not collect the name of the Deed Writer, and thereafter the Complainant sent a letter addressed to the Accused Persons No.1 to 3 on 24.08.2023 to the Accused Person No.1 to 3 by Registered Post, and the said notice duly served upon the Accused Persons on 25.08.2023, and thereafter the Complainant also lodged complaint before the S.P Purulia on 05.09.2023 and after 05.09.2023 the Accused Persons again given out threats to the Complainant that they will murder to the Complainant at any point of time so the Complainant file this petition for relief.
- 3) That, the Accused Persons are cheated to the Complainant and they are also trying to grab the property of the Complainant in collusion with some persons.

It is prayed, that your Honour would be pleased to admit the petition and to send this petition to O/C Boro P.S. and directing him to treat this petition as F.I.R. against the accused persons and also pass necessary order which will deemed fit and proper.
