The Disconnection was made due to non-payment of Electricity energy bill i.r.o. Consumer Id:- 242092040. Shri Suraj Hazra has committed theft of electricity u/s 138(1)(a) & 138(1)(b) of the Electricity (Amendment) Act-2007.

Roy, Sr. TSH has entered the premises of Suraj Hazra, S/O- Manik Hazra and inspected his premises. During inspection, theft of electricity was detected U/S 138(1)(a) & 138(1)(b) of Electricity (Amendment) Act-2007 i.e, he was using electricity unauthorisedly by reconnecting the energy meter having meter No. 750063324 consumer Id:-2420920 40 of W.B.S.E.D.C.L. with electric line being the property of a licensee when the said electric line has been disconnected.
