Suchitra Barat entered my house forcefully and physically abused me along with my daughter-in-law Smt. Chaina Barat with Iron Rod. Trying to murder us. Which lead to injury in shoulder, Abdomen and several other parts of our body. Immediately I along with my daughter-in-law was admitted to Hura Hospital.

Keeping in view the above incident it is my humble request that kindly take proper action against Smt. Suchitra Barat as per rules. Kindly treat this letter as F.I.R.
