Dear Sir,

I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Sri. Ashok Kumar Nandi** was enjoying Electricity un-authorizedly by reconnecting energy meter vide Meter No: **L2268309** Consumer Id: **200613780** of W.B.S.E.D.C.L.

On dated **10.01.2021** the meter was disconnected due to non-payment of Electricity Energy bill. And by reconnecting on his own **Sri Ashok Kumar Nandi** has committed theft of electricity u/s 138 (1) (a) & 138 (1) (b) of the Electricity (Amendment) Act-2007.

On dated **21.11.2023** at around **1:40 PM** myself Sri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Sri Biswajit Pal, J.E. (E) Gr.II and Sri. Sunil Kr. Roy, Sr. TSH both posted at Hura CCC, WBSSEDCL has entered the premises of **Sri. Ashok Kumar Nandi, S/o: Bijay Basanta Nandi** and inspected his premises. During inspection theft of electricity was detected u/s 138 (1) (a) & 138 (1) (b) i.e., he was using electricity by un-authorizedly reconnecting the energy meter which was disconnected by the office for non-payment of Electricity Energy Bill.

From the above arrangement, he was using the following electrical equipments:


1. Electric Light Bulb = 5 Nos
2. Electric Water Motor = 1 Nos

Out of which I seized the following electrical items:

1. Flexible Wire approx 15 Feet long.

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at around **2:00 PM** on **21.11.2023**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
