**Subject:- FIR Against Sri. Tuhin Kanti Mondal, S/o: Binod Bihari Mondal, resides at Vill: Lalpur Under Hura PS.**

Dear Sir,

I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Sri. Tuhin Kanti Mondal** was enjoying Electricity un-authorizedly by reconnecting energy meter vide Meter No: **B2203444** Consumer Id: **242162686** of W.B.S.E.D.C.L.

On dated **06.01.2020** the meter was disconnected due to non-payment of Electricity Energy bill. And by reconnecting on his own **Sri Tuhin Kanti Mondal** has committed theft of electricity u/s 135 (1) (e) , 138 (1) (a) & 138 (1) (b) of the Electricity (Amendment) Act-2007.

On dated **24.11.2023** at around **2:30 PM** myself Shri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, J.E. (E) Gr.II and Shri. Gur Pratap Singh, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of **Sri. Tuhin Kanti Mondal, S/o: Binod Bihari Mondal** and inspected his premises. During inspection theft of electricity was detected u/s 135 (1) (e) i.e., he was enjoying electricity other than the purpose for which it was supplied. (He was using Electricity for commercial Purpose instead of Domestic), 138 (1) (a) & 138 (1) (b) i.e., he was using electricity by un-authorizedly reconnecting the energy meter which was disconnected by the office for non-payment of Electricity Energy Bill.

From the above arrangement, he was using the following electrical equipments:

1. Electric Fan = 6 Nos
2. Electric Light Bulb = 10 Nos

Out of which I seized the following electrical items:

1. Flexible Wire = 10 feet approx.

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at around **2:50 PM** on **24.11.2023**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
