I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Sri. Ambuj Mandal was Supplying Electricity un-authorizedly by extension of electricity to deemed premises from his energy meter vide Meter No: L4373575 Consumer Id: 201616781 of W.B.S.E.D.C.L.

On dated 24.11.2023 at around 3:50 PM myself Shri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, J.E. (E) Gr.II and Shri. Gur Pratap Singh, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of Sri. Ambuj Mandal, S/o: Srimanta Mandal and inspected his premises. During inspection It was found that he was suppling electricity unauthorizedly to deemed premises i.e., uses electricity for the purpose other than for which the usage of electricity was authorised. u/s 135. (1) (e)

From the above arrangement, he was using the following electrical equipments:

- 1. Electric Light bulb = 5 Nos.
- 2. Electric Fan = 2 Nos

Out of which I seized the following electrical items:

1. Flexible wire = 15 feet approx.

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at around 4:10 PM on 24.11.2023.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
