In producing here with 01(one) arrested accused person namely Goutam Kumar (20 yrs.) S/O-Matuki Yadav of Vill-Baijala, PO-Sugwauran, PS-Jhajha, Dist-Jamui, (Bihar), Driver of vehicle bearing Reg. No- JH 10 CR/7796 (Truck) along with seized articles i.e. 01 (one) vehicle having registration No- JH 10 CR/7796 (Truck) loaded with approx 24 MTs Coal, seems to be steam Coal to the effect that on 24.11.2023 I ASI Amal Kr. Pati along with C/3398 Tarun Om, NVF/955 Ganapati Sing all of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) vide Hura P.S CC No 3438/23 Dtd 24.11.2023 and GDE No- 995 Dtd- 24.11.2023 and at about 14.05 hrs received information that a truck loaded with coal is going towards Ladhurka side. I informed the matter to O/C Hura P.S and as per his direction left towards Ladhurka side. we found that 01(one) vehicle bearing registration No- JH 10 CR/7796 (Truck) loaded with coal towards Dumdumi village side from Ladhurka side under Hura P.S. We managed to stop the said vehicle near at Ladhurka NAKA point and asked the driver to produce valid documents in respect of loaded coal but he failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the driver, owners of the said truck and others with ill motive was transporting the coal illegally without any valid documents in support of carrying coal. So, he committed offence punishable U/S-379/411/414/120B IPC & 30(2) CMN Act. Hence I seized the said Truck loaded with approx 24 MTs coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 03 kg from the truck and arrested the above noted accused driver after observing all formalities regarding arrest. All the procedure had happened in between 16.05 hrs. to 16.45 hrs. I brought the said seized Truck loaded with coal and arrested driver to Hura P.S and the vehicle kept at PS compound.

Therefore, I pray that a specific case may kindly be registered against 1) Goutam Kumar (20 yrs.) S/O- Matuki Yadav of Vill- Baijala, PO- Sugwauran, PS- Jhajha, Dist- Jamui, (Bihar), Driver of vehicle bearing Reg. No- JH 10 CR/7796 (Truck), 2) owner of the seized vehicle No- JH 10 CR/7796 (Truck) and others U/S- 379/411/414/120B IPC & 30(2) CMN Act. and arrange its investigation.
