Accordingly, myself accompanied with force left for Lalpur Morh under Hura PS vide C.C. No. 3461/23, Dtd-26/11/23. After reaching there at about 11:05 hrs. I found that the Road at Lalpur Morh (Bankura to Purulia (N.H-60A) has been blockade by above noted persons and some others 150/200 out of them some equipped lathi with them. They unlawfully assembled at Lalpur more after hatching up a criminal conspiracy at Hijuli village over the issue of yesterday's incident at Hijuli Football ground being led by the above noted persons blocked the National Highway (60A) on the issue of a football tournament and thus caused harassment of innocent people i.e. Bus passenger, drivers, riders etc and accordingly some persons joined in the unlawful assembly. I along with others officers have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob. It is also found more than 30/35 vehicles loaded with passengers and drivers including patients etc. from both sides i.e. Bankura & Purulia were detained there and subjected to enormous sufferings. We again tried to withdraw the blockade, but the above noted persons started obstructing us from removing the blockade. Thus obstructing public servant in discharge of their Govt. duty. They started pushing us in which me i.e. S.I Bangshi Badan Mondal and SI Kazi Kawsar Nafis and we sustained injury on our persons. Finding no other way, we called O/C Hura P.S for re-enforcement. After re-enforcement we managed to withdraw the blocked at about 11:45 hrs. and SI Kazi Kawsar Nafis admitted at Hura Rural Hospital. However, we have somehow managed the situation. During this situation I arrested 11 numbers of involved persons from the P.O. namely (1) Samsuddin Ansary S/O-Mohiruddin Ansary of Vill-Hijuli, PO-Daldali, PS-Hura, Dist-Purulia (2) Karim Ansary S/O-Sadhari Ansary of Vill-Banbaligara, PS-Purulia (M), Dist-Purulia (3) Kadir Ansary S/O-Jakir Ansary of Vill-Banbaligara, PS-Purulia (M), Dist-Purulia (4) Abdul Majid Ansary S/O-Giyasuddin Ansary (5) Siraj Ansary S/O-Anisur Rahaman Ansary (6) Atik Ansary S/O-Samaun Ansary (7) Sahel Ansary S/O- Majaffor Ansary all are of Vill-Hijuli, PS-Hura, Dist-Purulia (8) Afjal Ansari S/O-Arsad Ansari of Vill-Baghra, PS-Purulia (M), Dist-Purulia (9) Ismail Khan S/O- Kursed Khan of Vill-Chalkigora, PS-Barikul, Dist-Bankura (10) Sabir Ansary S/O-Jakir Ansary (11) Sajahan Ansary S/O-Joynal Ansary both of Vill-Ban Baligara, PS-Purulia (M), Dist-Purulia, after maintaining all the guideline of the Apex Court regarding arrest while others fled away from the spot. I also seized 05 numbers of Motor Cycles of the involved persons having bearing numbers (i) WB-56P/3722 (ii) WB-56S/5504 (iii) WB-56D/1297 (iv) JH-10BA/8805 (v) WB-82/9679 which were placed at the spot, 3pcs Lathi and 9pcs old footwears of the mob which they left during dispersing the mob with proper seizure list duly signed by the witnesses. All the process has been completed in-between 11:45 hrs

The above noted persons and others unlawfully assembled at Lalpur morh after hatching up a criminal conspiracy at Hijuli village over the issue of yesterday's incident at Hijuli Football ground being led by the above noted persons, obstructed National Highway at Lalpur Morh and accordingly some persons joined in the unlawful assembly. The above noted persons and others also obstructing public servant in discharge of their Govt. duty which led injuries to the Govt. servant severely and admitted at Hura Rural Hospital.

Therefore, I am requesting you to start a specific case against the above noted persons and other 150/200 persons under proper section of law of Hijuli village & Hijuli Soloana and arrange for its investigation.
