Sir,

I, SI- Surajit Kumar Das along with force returned to PS with 01 (one) arrested accd. person namely Riyasat Kazi (29) S/O Kalam Kazi of vill- Hussaindih, PS-Jhalda, Dist- Purulia along with seized article i.e. one Bi-cycle loaded with approx 0.7 Quintal of steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (08/11/2023) myself along with force namely C/814-Susabhan Goswami, NVF/843 Bibekananda Mahato were performing Spl. evening mobile duty in PS area vide Jhalda P.S. GDE No- 372/23 Dated- 08/11/2023 in consonance with Jhalda PS CC No- 3324/23 Dated-08/11/2023. During my Spl. evening mobile duty, at about 19:35 hrs, received a tip off that 01 (one) person is coming from Jharkhand side along Ichag more on Jhalda Bagmundi Pitch road towards Jhalda by a Bi-Cycle loaded with stolen steam coal. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 377 dated 08/11/2023. Consequently, as per your kind order I started Naka at Ichag More by placing the guardrail on the Jhalda Bagmundi Pitch road. Thereafter I saw the 01 (one) person was coming towards Ichag more. Consequently, we intercepted him along with 01 Bi-Cycle loaded with steam coal at Naka checking point at about 20:25 hrs. On being asked, he disclosed his identity as noted in the supra. I asked him to produce the valid documents in respect of the loaded steam Coal but he could not able to produce any kind of documents in respect of the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of the said steam Coal. So it is reasoned to belief that he procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized the said Bi-cycle loaded with approx 0.7 Quintal of steam coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the said accused namely Riyasat Kazi (29) S/O Kalam Kazi of vill- Hussaindih, PS-Jhalda, Dist- Purulia after informing him the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seized articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accused person namely Riyasat Kazi (29) S/O Kalam Kazi of vill- Hussaindih, PS-Jhalda, Dist- Purulia as he committed offence U/S- 379/411/413/414 of the IPC.
