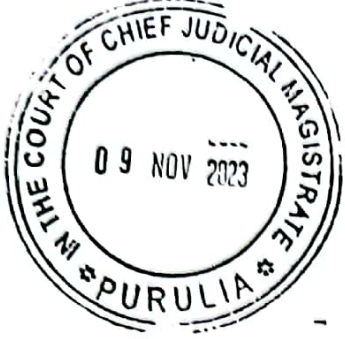
The complainant / petitioner above named begs to state as follows :-

1) That the accused no.1 is the husband and accused no. 2 is the brother in law and accused no. 3 Sister in Law (Baudi) of the accused no.1) ~~accused no.1~~ ~~brother in law~~ There the close relative of the husband of the complainants.

2) That the petitioner is the legally married wife of the accused Bijoy Karmali and their marriage was solemnized on 25/04/2019 , at Village Dumurdih under P.S. Jhalda according to Hindu rites and customs prevailing in their society and their marriage tie is still subsisting.

3) That after marriage the petitioner went to her matrimonial home at Village Priyatu under P.S. Rajrappa , Dist. Ramgarh and they used to live together as husband and wife. During his wedlock the petitioner gave birth of a male child on 23/01/2020. The name of said minor son of the petitioner is Anav Karmali.

4) That after birth of minor son of the petitioner the accused persons started to torture upon the petitioner physically and mantaly. At the time of marriage the father of the petitioner gave some of rupees 60 thousand and one Motor Cycle (hero glamor) Alongrats , Palang T.V . kooler , Dressing Table and others furniture to the accused person as per his demand . But the accused

person was not satisfied with the said amount and accordingly he father demanded cash of rupees 50 thousand from the father of the petitioner. The petitioner communicated the said demand of her husband to her father. But the father of the petitioner did not able to fulfill the said illegal demand of the accused person and accordingly the illtreatment, torture and harrasement upon the petitioner gradually increased by the accused persons. The accused person started to assault the petitioner mercilessly by fist & blows. And on 25/05/2023 the accused persons assaulted the petitioner mercilessly and he drove her out from his house and accordingly the complaint has compelled to go her father's house with her minor sons.

5) That on the date of occurrence on 10/07/2023 at about 10.00 A.M when the complainant / petitioner went to Jhalda for medical treatment of her minor son and at that time the accused person came and appear infrent of the complainant and he forcibly snatched away the said minor son from the lap of the complainant and he took away her minor son by a card after assaulting the complainant by fist and blow mercilessly.

6) That on the next day the father of the complainant went to the house of the accused person to bring back the minor son of the complainant but the accused persons did not allow him to enter into his house and he threaten to the father

of the complainant in a dire consequences.

- 7) That the minor son of the complainant is a milk sucking baby and the accused person illegally confined the minor in his house.
- 8) That the accused person illegally confined the minor baby of the complainant and he also kidnapped the minor from the legal custody of the complainant.
9. That the complainant has compelled to passing her life with great difficulties in absence of her minor son.
- 10) That the witness above named saw the incident and the matter was also reported to them.
- 11) That the complainant is a poor woman and she has got no means to conduct the case personally and as such police case is required for the ends of Justice.

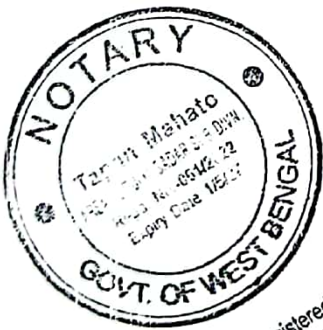
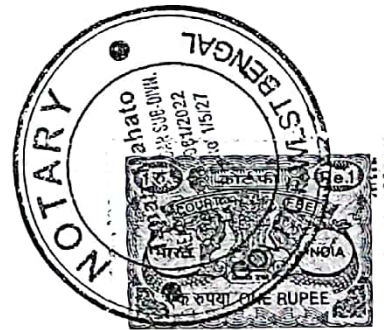
