Sir,

In producing here with one accused person namely Anil Kumar Soni (51 yrs) S/o-Indradeb Sonar of Gram Jarmuney, P.O-Jarmuney Than-Bagodar Dist-Giridih State-Jharkhand (Driver of Truck No- JH02AB-8677) along with seized articles i.e. 01 (one) truck having Registration No- JH02AB-8677 loaded with approx 24 ton coal also taken sample of 03 kg from the Truck, to the effect that I, ASI Tarapada Hazari along with C/-1358 Sanjib Patra, C/-2217 Souvik Rana & NVF/-018 Biswanath Mahato all of Joypur PS Dist-Purulia vide CC No-2466/23 Dated-01/11/2023 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS, Dist-Purulia and found the above noted truck was coming from Bokaro side via NH-32 towards Kathaltard at about 13:50 hrs. On seeing the Naka Checking party stopped the truck and found that loaded huge quantity of illegal coal, he tried to fled away, after hot chase we able to apprehended the above noted person. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will sell illegal coal somewhere in Purulia. On demand he failed to produce any valid papers in respect of possessing or selling of coal. So it is reasonable to believe that the Driver & owner of the above noted truck collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted truck transporting coal illegally. So I seized the same under proper seizure list in between 14:15 hrs to 14:35 hrs & label duly signed by witnesses after taking sample of 03 kg coal from the truck. During further interrogation he confessed his guilt as such I arrested him today 01/11/2023 at 14:40 hrs after issued proper memo of arrest & check list as the accused person is liable for prosecution U/S-379/411/414/120B IPC.

I therefore pray before you, kindly lodge an FIR against the owner of the truck bearing Regd. No-JH02AB-8677 and arrested accused driver Anil Kumar Soni (51 yrs) S/o-Indradeb Sonar of Gram Jarmuney, P.O-Jarmuney Than-Bagodar Dist-Giridih State-Jharkhand U/S-379/411/414/120B IPC and arrange for its investigation.
