In producing herewith the arrested accused persons namely (1) Basaki Mahato @ Binata Mahato (30 yrs) W/o-Paresh Mahato (2) Sarita Mahato (45 yrs) W/o-Prabhash Mahato (3) Aloka Mahato (45 yrs) W/o-Lalu Mahato (4) Panchami Mahato (35 yrs) W/o-Nibash Mahato (5) Basanti Mahato (30 yrs) W/o-Thakurdas Mahato with lap baby (6) Purnima Mahato (30 yrs) W/o-Sarbeswar Mahato (7) Namita Pandey (40 yrs) W/o-Gopal Pandey (8) Usha Mahato (22 yrs) W/o-Manotosh Mahato with lap baby (9) Pinki @ Pramila Mahato (20 yrs) W/o-Bhriguram Mhato with lap baby (10) Kalabati Mahato (50 yrs) W/o-Hiralal Mahato (11) Belli @ Belarani Mahato (35 yrs) W/o-Dharani Mahato (12) Lalita Pandey (50 yrs) W/o-Shamsundar Pandey (13) Chhobi Mahato (40 yrs) W/o-Karamchand Mahato received minutely injuries All are of Vill-Agharpur PS-Joypur Dist-Purulia along with seized articles viz (i) 28 pieces of stone (ii) 09 pieces of bamboo stick. I Inspector Liton Rakshit, Inspector In-Charge Joypur Police Station do hereby lodged complaint, to the effect that today (04/11/2023) construction work of boundary wall of proposed industrial hub at Aghorpur Mouza under PS Joypur was started as per order General manager (in charge), District Industries Centre, Purulia vide Memo No 517/DIC/PRL/2023-24 date 31/10/2023 from 09.00 hrs in presence of Sri Biswaranjan Chakraborty, WBCS (Exe) DM&DC, Purulia Executive Magistrate as detail by Date-03/11/2023 with Additional District Magistrate (G) Purulia vide Memo No-524(7)/1 proper Police protection. At about 11.45 hrs approx 50 (fifty) women all of Agharpur village assembled at the spot (Construction working place) and started to howling as well as tried to stop constructional work forcefully. Accordingly, LSI Sumana Kar of Purulia (M) PS along with lady constables and deputed Executive Magistrate tried to stop them from such unlawful activities and also tried to convince them. But they did not pay any heed on their words. They started more nuisance and halla with ill motive to stop the constructional work. Hence deputed Executive Magistrate started miking and requested them to disperse from the spot. But they were remained unchanged rather their body languages became more furious and they also started abusive languages. They also pushed the lady constables. At that time deputed Executive Magistrate declared the mob as unlawful and all were directed to dispersed immediately. Being unlawful mob, they became more aggressive and tried to over powered the Police personnel and started to assault Police personnel by stone and bamboo stick with intend to kill them. As a result, three Police personnel namely (1) C/-3342 Mahabir Kaibartya (2) C/-3179 Biplab Mahato & (3) LC/-443 Sanjati Majhi, received serious bleeding injury on their head, forehead and various parts of body. Seeing no alternative way as per order of Deputed Executive Magistrate and as per direction of mine, LSI Sumana Kar of Purulia (M) PS arrested above noted accused persons after maintaining all formalities guided by NHRC and seized the said above noted offending articles with proper seizure list. Thereafter the injured Police

personnels has been rescued and shifted to Joypur BPHC for their treatment, where attending Doctor admitted them according their nature of injuries. The above noted arrested accused persons committed offence U/S-143/ 147/186/188/333/353/307/506/34 IPC. It is clear from their words that there are few others who were involved in this crime. Whole process has been videography.

In the circumstances I therefore request you to lodge an F.I.R U/S- 143/147/186/188/333/353/307/506/34 IPC against the above noted all arrested persons and others as well as arrange for its investigation.
