In producing here with 03 (three) arrested accused persons namely (1) Fulchand Tudu (48 yrs) S/o-Late Ramnath Majhi @ Tudu of Vill-Karhariya (2) Santosh Kumar Pal (25 yrs) S/o-Rajnath Pal of Vill-Kurmidih both of PS-Balidih Dist-Bokaro State-Jharkhand (3) Sanjoy Soren (25 yrs) S/o-Motilal Soren of Vill-Barokenduw PS-Petorbad, Dist-Bokaro State-Jharkhand along with seized articles i.e. 05 (five) Motor Cycles without registration loaded with approx 10 quintal steam coal as per seizure list and submitting a written complaint against the motor cycles rider, to the effect that today i.e. 05/11/2023 myself along with C/-2109 Santanu Lohar, NVF/-0901 Sibeswar Kuiry both of Baglata IC under Joypur PS Dist-Purulia were performing mobile duty at PS area vide GDE No-125 Dated-05/11/2023. During mobile duty at about 07:45 hrs received credible source information that 05 Motor Cycle without registration loaded steam coal were coming from Balidih PS area under Jharkhand State towards Joypur side under Joypur PS. After receiving source information, I informed the matter to IC Joypur PS and as per your kind direction we proceeded to work out the information. We stop the Motor Cycles loaded with coal and found that approx 10 quintal steam coal with their motor cycles near Dimdiha Bridge under Joypur PS. On seeing Police persons, they tried to fled away, after hot chase we able to apprehended the above noted 03 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at Joypur Bazar area under Joypur PS. On demand they failed to produce any valid papers in respect of possessing selling of steam coal. So, it is reasonable to believe that the Motorcycles rider collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the Motorcycles transporting steam coal illegally. So, I seized the same under proper seizure list in between 12:25 hrs to 12:55 hrs & label duly signed by witnesses after taking sample of 01 kg steam coal. During further interrogation they confessed their guilt as such I arrested them at 13:05 hrs to 13:15 hrs as the accused persons are liable for prosecution U/S-379/411/414 IPC.

So, I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Fulchand Tudu (48 yrs) S/o-Late Ramnath Majhi @ Tudu of Vill-Karhariya (2) Santosh Kumar Pal (25 yrs) S/o-Rajnath Pal of Vill-Kurmidih both of PS-Balidih Dist-Bokaro State-Jharkhand (3) Sanjoy Soren (25 yrs) S/o-Motilal Soren of Vill-Barokenduw PS-Petorbad, Dist-Bokaro State-Jharkhand with proper section of law and arrange for its investigation.
