I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Dilip Sahis, S/O- Fatik Sahis of Vill- Ghagra, Tola- Goriatard, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135 1(a) of electricity act 2003 subsequently amendment act 2007.

On 07.11.2023 at about 12.40 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC and 02. Ganesh Mahato, Gr-I TSH, Joypur CCC entered the premises of Dilip Sahis, S/O- Fatik Sahis of Vill- Ghagra, Tola- Goriatard, P.S- Joypur , Dist- Purulia and found that Dilip Sahis, S/O- Fatik Sahis was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through PVC pink colour 2 core 1 sq mm copper wire with hooking arrangement (approx 18 mtr) by means of direct hooking to his domestic premises and connected load found 0.389 kW. As Dilip Sahis, S/O- Fatik Sahis committed theft of electric power, I seized the following articles after preparing the seizure list in presence of 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC and 02. Ganesh Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 12.55 P.M.

01. PVC pink colour 2 core 1 sq mm copper wire with hooking arrangement (approx 18 mtr).
