I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Sitaram Sahish, S/O- Late Kalipada Sahish of Vill- Ghagra, Tola- Goriatard, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135 1(a) of electricity act 2003 subsequently amendment act 2007.

On 07.11.2023 at about 1.15 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC and 02. Ganesh Mahato, Gr-I TSH, Joypur CCC entered the premises of Sitaram Sahish, S/O- Late Kalipada Sahish of Vill- Ghagra, Tola- Goriatard, P.S- Joypur , Dist- Purulia and found that Sitaram Sahish, S/O- Late Kalipada Sahish was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through PVC black colour 2 core 4 sq mm alluminium cable with hooking arrangement (approx 21 mtr) by means of direct hooking to his domestic disconnected premises having meter No. 345300 and Consumer ID: 242278045 and connected physical load found 0.316 kW. As Sitaram Sahish, S/O- Late Kalipada Sahish committed theft of electric power, I seized the following articles after preparing the seizure list in presence of 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC and 02. Ganesh Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 1.10 P.M.
