Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Enayet Ansary, S/O- Late Jamal Uddin Ansary (present user) of Vill- Dambera, PO- Karkara, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 10.11.2023 at about 04.05 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01. Ganesh Mahato, Gr-I TSH, Joypur CCC and 02. Shibram Mahato, Gr-I TSH, Joypur CCC entered the premises of Jamal Uddin Ansary, S/O- Late Motilal Ansary of Vill- Dambera, PO- Karkara, P.S- Joypur , Dist- Purulia and found that at present Jamal Uddin Ansary is died and Enayet Ansary, S/O- Late Jamal Uddin Ansary was enjoying electricity unauthorizedly connecting with the service connection of Jamal Uddin Ansary, S/O- Late Motilal Ansary (Meter No. 7S0207485) and enjoying power from the LTOH line of WBSEDCL. The connection was disconnected on 15/10/2019 due to non payment of outstanding dues of energy bill. During inspection it is found that Enayet Ansary reconnects the service connection with LTOH line unauthorizedly and enjoying power in his premises. Contractual load of the connection (Consumer ID: 242163910) is 0.590 kVA. The connection is disconnected from LTOH line with final meter reading 013788.6. As Ansary, S/O- Late Jamal Uddin Ansary (present user) committed theft of electric power, I partially seized the following articles after preparing the seizure list in presence of 01. Ganesh Mahato, Gr-I TSH, Joypur CCC and 02. Shibram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 04.20 P.M.

Seized Articles:

01. PVC black colour 4 sq mm 2core alluminium cable (approx 6 mtr).

Enayet Ansary, S/O- Late Jamal Uddin Ansary (present user) of Vill- Dambera, PO- Karkara, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
