**Ref:** Joypur PS Case No-148/2023 Dated-11/11/2023 U/S-46A (c) of the Bengal Excise Act 1909.

Sub: Forwarding report of arrested FIR named accused Ramdas Sardar (48 yrs) S/o-Late Shambhu Sardar of Vill- Litiadih PS-Joypur, Dist-Purulia.

Respected Sir,

In forwarding herewith the accused person namely Ramdas Sardar (48 yrs) S/o-Late Shambhu Sardar of Vill- Litiadih PS-Joypur, Dist-Purulia with original copy of FIR, original seizure list and along with all relevant papers in c/w above noted case under proper Police escort.

The fact of case is in brief that on 11/11/2023 acting on a tip off in between 17:25 hrs to 18:25 hrs at Litiadih village under Joypur PS, ASI Tarapada Hazari with accompanied force reached at Litiadih village under Joypur PS and arrested Ramdas Sardar (48 yrs) S/o-Late Shambhu Sardar of Vill- Litiadih PS-Joypur, Dist-Purulia and found that he was selling illicit liquor (locally known as Mohulla) without any valid authority. Hence, he seized one white colour plastic Jariken containing approx 14 (fourteen) liter Illicit liquor (locally known as Mohulla) which was kept at his dwelling house and arrested the accused person. Over this above noted Case has been started endorsement of IC Joypur PS. I, ASI Nisith Ch Das took up the investigation of this case.

During investigation, the involvement of the above noted accused person Ramdas Sardar (48 yrs) S/o-Late Shambhu Sardar of Vill- Litiadih PS-Joypur, Dist-Purulia is strongly conspired in this case as he illegally stocked & sells of the Liquor without taking any prior permission from the authority.

In this regard, I pray before Honour's Court that the above noted accused person namely Ramdas Sardar (48 yrs) S/o-Late Shambhu Sardar of Vill- Litiadih PS-Joypur, Dist-Purulia may kindly be taken into your Honour custody and detained in J.C till the completion of investigation.

I oppose his bail at the initial stage of investigation.

I further pray before your kind honour that necessary order may kindly be passed to hand over the case along with seized alamat to OC Excise Joypur Circle, Purulia for further investigation of the case.
