Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Jayadeb Ghatuyal, S/O- Late Ramdhan Ghatuyal of Vill & PO- Baragram , P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 29.11.2023 at about 2.35 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01. Gajadhar Mahato, DE(E), Purulia Region Office, 02. Vikram Singh, JE(E) Gr-I, 03. Raushan Kumar, JE(E) Gr-II, Joypur CCC and 04. Shibram Mahato, Gr-I TSH, Joypur CCC entered the premises of Jayadeb Ghatuyal, S/O- Late Ramdhan Ghatuyal of Vill & PO- Baragram, P.S- Joypur , Dist- Purulia and found that Jayadeb Ghatuyal, S/O- Late Ramdhan Ghatuyal was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Jayadeb Ghatuyal with meter No. HR041367 was disconnected on 14/01/2020 due to non payment of energy bill. During inspection it is found that Jayadeb Ghatuyal reconnects his service connection with LTOH line unauthorisely and enjoying power in his premises. Contractual load of his connection (Consumer ID: 200861769) is 0.010 kVA and physical load found 0.120 kW i.e. 0.141 kVA. The connection is disconnected from LTOH line with final meter reading 001684. As Jayadeb Ghatuyal, S/O- Late Ramdhan Ghatuyal committed theft of electric power, I partially seized the following articles after preparing the seizure list in presence of 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC and 02. Shibram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 2.50 P.M.

Seized Articles:

01. PVC black colour 4 sq mm 2core alluminium cable (approx 7 mtr).

Jayadeb Ghatuyal, S/O- Late Ramdhan Ghatuyal of Vill & PO- Baragram, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
