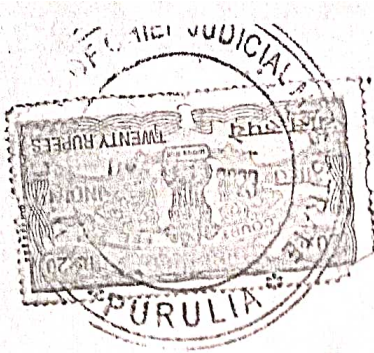

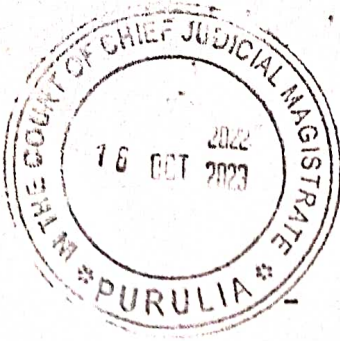

- 1) This is to inform you that I am a resident of Village - & P.O. Begunkodar P.S. Kotshila, Dist. Purulia. I also mention this petition that I have been care taking all the goddess including Durga Mandir on behalf of Royal family Rani Lochan Kumari Devi of Begunkodar. Ranilochan Kumari Devi died since 25-30 years back. On that day said unsocial accused persons obstructed for taking some grand money. They locked Durga mandir when we clean the said mandir premises.
