Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act-2007 to the effect that SRISTIDHAR KARMAKAR (Present User) , S/o- LT. RENGU KARMAKAR, resident at KOCHAHATU, PS- KOTSHILA, Dist- PURULIA was enjoying electricity unauthorized i.e. Service cable tapping from existing Service Cable due to this reason he has committed theft of electricity U/s 135 (I) (b) of the electricity (Amendment act-2007), detected on 28.11.2023 at 01.50 PM.

Entered the premises of KHENTI KARMAKAR having consumer id 203233434 and Installed Meter no G02723299 at KOCHAHATU to make an inspection, during the inspection it was found that SRISTIDHAR KARMAKAR (Present User) , S/o- LT. RENGU KARMAKAR, was using electricity unauthorisedly in the name of KHENTI KARMAKAR (consumer) but the said user was bypassed the meter by cutting the said service cable of his domestic premises. We then disconnected the said meter and service cable and seized the service cable on spot, leveled the seized article and prepared the inspection report on spot and left the premises at about 2.30pm. causing huge revenue loss to WBSEDCL which comes U/S 135(I) (b) of I.E ACT 2003. From the above by-passing system he/she uses the following electrical equipments.

Out of which I seized the following.

1. Two core 6sq mm PVC AL Service Cable, black in color of length 30 feet's (a portion of existing service cable), fitted with tapping cable.

Seizure list was prepared at the site and accused person refused to sign. The inspection team left the premises at 02.30 P.M on 28.11.2023. The accused person has committed an offence U/S 135(I)(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
