Sub:- Complaint regarding escaping of FIR named accused namely Sunil @ Mithun Sing Patar (31yrs) S/O Shaktipada @ Netai Sing Patar in c/w Manbazar P.S. Case No. 89/2023 Dated 06-11-2023 U/S 376 IPC.

Respected Sir,

I LSI Elora Rakshit of Manbazar P.S. hereby inform you that, on 06-11-2023 at 23:25 hrs. received a written complaint from one Kedar Sing S/O Lt. Khandu Sing of village-Tentla, PS- Manbazar, Dist- Purulia to the effect that on 06.11.2023 at about 18:00 hrs. while his wife was making Roti in kitchen room in his house at that time one Sunil @ Mithun Sing Patar S/O Shaktipada @ Netai Sing Patar of same village entered in the house of the complainant and forcibly Raped his wife finding her alone. As a result his wife received vaginal bleeding injury and shifted to Manbazar Rural Hospital for treatment from where she has further been referred to Deben Mahato Govt. Medical College & Hospital Purulia and now under treatment. Over this, Manbazar P.S. Case Number 89/2023 Dated 06-11-2023 U/S 376 IPC was recorded and as per endorsement of O/C Manbazar P.S. I took up investigation of this case.

During investigation of this case I went the P.O. and arrested the FIR named accused namely Sunil @ Mithun Sing Patar (31yrs) S/O Shaktipada @ Netai Sing Patar, of Tentla village, P.S. Manbazar, Dist. Purulia in C/W above noted case reference who was kept at Manbazar P.S. Lock-up.

Today on 07-11-2023 at 06:05 hrs. I informed SI Prabir Kr. Dey to conduct regular medical examination of the accused namely Sunil @ Mithun Sing Patar at Manbazar Rural Hospital & instructed the sentry duty NVF-637 Chunaram Murmu reference GDE number 249 to open the lock of the PS hazat for conducting the regular medical check-up. Immediately after I heard a hue & cry & stepped out of the Duty officer's room & found the accused fled away. I accompanied with Chunaram Murmu rushed to catch the accused but in vain. Thereafter NVF-637 Chunaram Murmu reported before me that the accused escaped by punching him & hitting on his nose & pushing him back. I immediately forwarded him Manbazar rural hospital for medical treatment.

On the basis of above noted incident I submitted Suo-Moto complaint before O.C Manbazar P.S. to start a case against Sunil @ Mithun Sing Patar (31yrs) S/O Shaktipada @ Netai Sing Patar, of Tentla village, P.S. Manbazar, Dist. Purulia as per law.
