entered the premises of Gorachand Gope s/o- Late Bhaskar Gope of village- Gosaidih, P.O- Shyampur, P.S- Manbazar, St- Purulia and inspected his premises and found that he was using electricity unauthorisely by direct hooking from LTOH line and he was a defaulter consumer having Consumer ID-203048999 with outstanding dues 36,525/- (Thirty Six thousand five hundred & twenty five only)

During inspection, theft of electricity was found i.e he was using electricity dishonestly u/s 135(1)(a) was detected. It was also found that he was using the following the following electrical equipments.

1) Two no's. inean. Bulls 40 Watt each.

2) Two no's Ceiling fans.

out of which we seized the following

1) 6 mtr 2 Core white Colour flexible Cord with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 15.35 hr. on dated 23.11.23. The accused person has committed an offence u/s 135(1)(a) of the Electricity (Amendment) Act-2007.
