In producing here with one accused person Jagjiban Bauri (38) S/O Nakari Bauri , village- Jitujuri, PS- Manbazar District Purulia along with following seized articles viz-


- 1) 10 (Ten) Ltrs ID liquor in one plastic Jerrycan .
- 2) Mc-Dowell's No-1 Luxury -04 pcs. containing 180 ML each
- 3) Mc-Dowell's No-1 Celebration Rum -01 pc. containing 180 ML

I ASI Pravash Ch Bauri of Manbazar PS do here by lodged a complaint against accused namely Jagjiban Bauri (38) S/O Nakari Bauri , village- Jitujuri, PS- Manbazar District Purulia to the effect that today (27.11.2023) at 17:25 hrs. in course of my evening mobile duty vide Manbazar PS G.D.E. No.1078 Dtd. 27.11.2023. I received a telephonic information from a reliable source that one Jagjiban Bauri (38) S/O Nakari Bauri , village- Jitujuri, PS- Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/888 Subhasish Hansda and C/855 Tarun Mahato rushed to the spot for raid by Govt. vehicle. At about 18:10 hrs. myself along with force reached at Rajendra Line Hotel near Petrol pump at Jitujuri village and held raid in the said Line Hotel of Jagjiban Bauri S/O Nakari Bauri , village- Jitujuri, PS- Manbazar District Purulia and found that said person selling ID liquor in his said Line Hotel. Seeing the police party some persons fled away and said Jagjiban Bauri tried to conceal himself but we were able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused person and available witnesses.

Hence, I pray that, a specific case may kindly be started against arrested accused person Jagjiban Bauri (38) S/O Nakari Bauri , village- Jitujuri, PS- Manbazar District Purulia as per law and arrange for its investigation.
