Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Rabi Mandal (36 yrs) S/O- Subodh Mandal of Vill-Sarbari Bauri Para, PS-Neturia, Dist-Purulia with seizure of 19 pcs sealed bottles of Dilkhush Country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (11.11.2023) while I, ASI Sitaram Mandi, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-451 Dt. 11.11.2023 and acting on source information after consulting you at about 17:35 hrs reached at village Sarbari Bauri Para and held raid in the house of Rabi Mandal (36 yrs) S/O- Subodh Mandal of Vill-Sarbari Bauri Para, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 19 pcs sealed bottles of Dilkhush Country spirit containing 375 ml each which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Rabi Mandal (36 yrs) S/O- Subodh Mandal of Vill-Sarbari Bauri Para, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1098 Tarani Singh Sardar (2) NVF/487 Kirtan Singh Sardar and (3) NVF/1051 Biswajit Mahato all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Rabi Mandal (36 yrs) S/O- Subodh Mandal of Vill-Sarbari Bauri Para, PS-Neturia, Dist-Purulia under proper section of law.
