Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sankasan Roy S/O-Lt Lakshmikanta Roy of Sarbari More (Roy Tailors) P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 (1) (a) of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **24.11.2023** at about **12:10PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with (1) Sri Partha Chakroborty, DE (E), Purulia Region Office, (2) Sri Sibdas Ball, J.E. (Gr-I) and (3) Sri Shrabanta Mandal, Linesman both attached to Saltore CCC and others had been to Sarbari More for routine inspection purpose. During inspection it was found that **Sankasan Roy S/O-Lt Lakshmikanta Roy** was consuming electricity dishonestly and unauthorisedly in his commercial premises namely "ROY TAILORS" by means of direct hooking from nearest electric pole, which resulted causing loss of revenue of WBSEDCL, Total load found to the tune of 0.4kW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected and two core pvc wire of approx. 16 ft length of black colored with hooking device used for the illegal activity has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list and the accused person also put his signature in the Seizure List and Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives signed on the same. The inspection team left the aforesaid premises at about **12:45 PM**.

Thus the accused **Sankasan Roy S/O-Lt Lakshmikanta Roy of Sarbari More (Roy Tailors) P.S -Neturia, Dist- Purulia** have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
