Sub:- Complain for starting a specific case .

Sir.

In producing herewith one arrested accused person namely Sani Soren (33 Yrs) S/O- Dulal Soren of Vill-Manoharchak, PO-Dishergarh, PS-Kulti, Dist- Paschim Bardhaman (Driver of the Tractor No- WB 37C/7191) along with the seized tractor having registration No- WB 37C/7191 (Mahindra B 275 DI, Bhoomiputra), Chassis No-NFNB00404, Engine No- NFNB00404 along with trolley loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, ASI Rajkumar Goswami along with C/1550 Bharat Ghosh, C/564 Prasad Majhi and C/3180 Ratan Navek all are of Neturia PS were performing anticrime evening mobile duty vide Neturia PS GD No- 1296 Dt. 31.10.23 & CC No- 3680//23 Dt. 31.10.23 at PS area and today on 31.10.2023 at about 17:25 hrs while performing mobile duty at Parbelia Bazar received a credible source information that one tractor bearing registration No- WB 37C/7191 is loading sand illegally at Deoli Ghat. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Deoli Ghat at about 17:45 hrs reached at Deoli Ghat and found that above noted tractor was standing there loaded with sand in trolley. After seeing the police team the driver started to run towards dark area of the riverbed of Damodar River but after hot chase we managed to apprehend him and on being asked to produce documents/challan in respect loaded sand in the vehicle as well as the papers of the vehicle, but he failed to produce. On being asked he disclosed his identity as noted above. On preliminary enquiry and as per his statement it could be learnt that he along with owner of the tractor having registration No- WB 37C/7191 procured the sand from Deoli Ghat illegally.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sanctoria side under Kulti PS knowing it to be stolen.

Accordingly, I seized the tractor having registration No- WB 37C/7191 along with trolley loaded with sand approx 100 C.FT at 18.45 hrs under proper seizure list duly signed by witnesses and arrested the accused driver at 19:05 hrs after maintaining all formalities of arrest rule. So, the driver and registered owner of the vehicle have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of tractor No- WB 37C/7191 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
