Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Nibas Bauri (50 yrs) S/O- Lt. Kamal Bauri of Vill-Digha (Bauri Para), PS-Neturia, Dist-Purulia with seizure of 15 pcs sealed bottles of Dil Se Country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (23.11.2023) while I, ASI Sitaram Mandi, along with force were performing raid duty vide Neturia PS GDE No-962 Dt. 23.11.2023 and acting on source information after consulting you at about 19:25 hrs reached at village Digha (Bauri Para) and held raid in the house of Nibas Bauri (50 yrs) S/O- Lt. Kamal Bauri of Vill-Digha (Bauri Para), PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 15 pcs sealed bottles of Dil Se Country spirit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Nibas Bauri (50 yrs) S/O- Lt. Kamal Bauri of Vill-Digha (Bauri Para), PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/2357 Palash Mukherjee (2) C/2559 Bachan Dangar and (3) NVF/660 Ranjit Kumbhakar all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Nibas Bauri (50 yrs) S/O- Lt. Kamal Bauri of Vill-Digha (Bauri Para), PS-Neturia, Dist-Purulia under proper section of law.
