Para Dist- Purulia.for theft of electricity by tapping from the input side of service cable of WBSEDCL, U/S - 135(1)(b) of Electricity Act 2003 amended in 2007.

Today (02.11.2023) in between 1:50 p.m. and 2:30p.m., myself along with Sri Pradip Choudhury, Divisional Manager, Raghunathpur Division, Sri Goutam Mandal, JE-I, Bhaktipada Mahato, TSH, Patit Kr. Kora, Sr. TSHall of Dubra Para CCC and others on the basis of a secret source information inspected the premises of user Sri Sadhan Dhibar, S/O, Raman Chandra Dhibar, resident of Vill+PO- Bahara, P.S. Para Dist- Purulia. During inspection it was found that user accused Sadhan Dhibar was using electricity unauthorizedly and dishonestly in his domestic premises by tapping from the input side of service cable vide consumer ID:201330450, Meter No: 347632of WBSEDCL with the help of two no single core PVC cable found one end in bend condition to use as tapping device.
