Sub- Lodging of complaint against Gajeswar Kumbhakar, S/O, Shubhal Kumbhakar, resident of Vill- panara for theft of electricity hooking u/s 135(1)(a) of Electricity Act -2003 amended in 2007

I Abhishek Rai, S/o, Vijay Prakash Rai, Assistant Engineer and Station Manager of Dubra Para Customer Care Centre, WBSEDCL, being authorized under the Electricity Act-2003 amended in 2007, do hereby lodge complaint against user Gajeswar Kumbhakar, S/O, Shubhal Kumbhakar, resident of Vill- panara, P.O. Nadiha, P.S. Para, Dist- Purulia. for theft of electricity by direct hooking with the help of hooking cable from the nearby LTOH line of WBSEDCL, U/S – 135(1)(a) of Electricity Act 2003 amended in 2007.

Today (02.11.2023) in between 3:10 p.m. and 3:45p.m., myself along with Sri Pradip Choudhury, Divisional Manager, Raghunathpur Division, Sri Goutam Mandal, JE-I, Bhaktipada Mahato, TSH, Patit Kr. Kora, Sr. TSHall of Dubra Para CCC and others on the basis of a secret source information inspected the premises of user Sri Gajeswar Kumbhakar, S/O, Shubhal Kumbhakar, resident of Vill- panara, P.O. Nadiha, P.S. Para, Dist- Purulia. During inspection it was found that user accused Gajeswar Kumbhakar was using electricity unauthorizedly and dishonestly in his domestic premises by direct hooking from the nearby LTOH line of WBSEDCL with the help of two core flexible wire found one end in bend condition to use as hooking device. So, he committed theft of electricity and liable for prosecution U/S 135(1)(a) of Electricity act 2003 amended in 2007.

The inspection report was prepared by Sri Goutam Mandal, JE-I at the spot and the load of the premises was assessed as 0.3 KW. Sri Bhaktipada Mahato, TSH removed the hooking device and cable from the LTOH line of WBSEDCL as per my direction. The materials used for theft of electricity were seized by me. Copy of Seizure list and Inspection report could not be handed over to the accused as he and others refused to accept those.

The inspection team left the site at 3:55 p.m. on 02.11.2023 after completion of inspection & raid. It is well proved that user Gajeswar Kumbhakar, S/O, Shubhal Kumbhakar, resident of Vill- panara, P.O. Nadiha, P.S. Para, Dist- Purulia committed theft of electricity by direct hooking from nearby LTOH line of WBSEDCL as such he is liable for prosecution u/s 135(1)(a) of Electricity act 2003 amended in 2007.

So, you are requested to treat this complaint as F.I.R.
