Entered the premises of Manik Bauri, s.o- Late Dasu Bauri of Village- Jorberia, P.O- Jorberia, P.S- Para, Dist-Purulia. and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by means of direct hooking from LTOH of WBSEDCL.

Supply i.e. U/S 135(i) a was detected.

From the above system he/she was using the following Electrical equipments i.e.

2 Fans $\Rightarrow 80 \text{ wt} \times 2 = 160 \text{ wt}$
4 led light $\Rightarrow 10 \text{ wt} \times 4 = 40 \text{ wt}$ } 200 wt.

Out of which we seized the following:

Hooking device (0.75 sqmm single green color copper wire) approx length 95 mtr.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 08/11/23 07:40 pm on dated 08/11/23. The accused person has committed an offence U/S-135(i) a of the Electricity (Amendment) Act-2007.
