Sir,

In producing herewith the seized articles under proper seizure list (enclosed herewith) viz (i) Exhibit Mark 'A' i.e one 05 ltr. transparent plastic Jaricane along with green coloured cap containing appx. 5 Lit. of light red coloured contraband codeine mixture (overall weight of the jaricane including codeine mixture measuring 6 kg 204 grams), from which samples of 02 bottles of approx 100 ml each taken out for test sample and security sample marked as exhibit 'B' & 'C' (ii) Exhibit Mark 'B' i.e one bottle containing appx. 100 ml of codeine mixture as test sample (overall weight of the bottle including codeine mixture measuring 120 gams) (iii) Exhibit Mark 'C' i,e one bottle containing appx. 100 ml of codeine mixture as security sample (overall weight of the bottle including codeine mixture measuring 129 gams). All Exhibits are in properly sealed and labeled condition under proper seizure list before you. I, SI Shuvankar Sarkar, In-Charge Santaldih I.C (BCW) under Santaldih PS do hereby submit a written complain to the effect that on 20.11.2023 I along with officer ASI Haradhan Ghosh interrogated the PC accused person namely Sagar Osta S/o- Kismat Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia in C/W Santaldih PS Case no 67/23 dated 14.10.2023 U/S- 380 IPC. He confessed his guilt and the PC accused stated that he committed the theft in the house of Asit Mahatha of Vill- Joradih in the 13/14- 10.2023 night and took away one motorcycle with him and he kept the motorcycle in consoled manner in his house premises and he would help the police party for recovery the same. Subsequently, I recorded his disclosure statement and informed whole the matter to IC Santaldih PS. The matter is diarized vide Santaldih I.C (BCW) G.D.E. No- 394 date- 20.11.2023.

Accordingly, on 20.11.2023 at 18:35 hrs I accompanied with IC Santaldih PS along with ASI Haradhan Ghosh and C/29- Koushik Ghatak, C/948- Ramen Pramanick with the PC accused Sagar Osta S/o- Kismat Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia, left for Para PS, Dist- Purulia to work out the disclosure statement of PC accused in order to recover the stolen motorcycle. At about 19:25 hrs we reached at Para PS, Dist-Purulia and submitted a requisition for police assistance for holding raid. We along with ASI Mrityunjoy Bhakat and C/561- Dhananjay Mudi of Para PS left for Bamunbaid village to work out the same. At about 20:25 hrs we reached at the house of PC accused Sagar Osta S/o- Kismat Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia and there from his house he showed and brought one black colour Hero motorcycle without number plate bearing engine number- HA10AGJHKF2064 & chassis number- MHLHAR07XJHK95662 and I seized the motorcycle under proper seizure list in C/W Santaldih PS Case no 67/23 dated 14.10.2023 U/S-380 IPC. Further leading to the statement of PC accused Sagar Osta, we conducted search in his house in order to recover the tools (house breaking/ motorcycle lock breaking) used during the commission of crime.

During search, we also found one white colour 5 ltr plastic jaricane containing liquid which seems as contraband like substance (Codeine Mixture). At the time of the opening cap of the jar aromatic smell of contraband Codeine mixture was coming out from the jar. During further interrogation, PC accused Sagar Osta stated that it was codeine mixture and very recent he started this illegal business with another person namely Tayab Ansary S/o- Late Isak Ansary of Belma, PS- Purulia (M), Dist- Purulia. Then, at about 20:52 hrs IC Santaldih PS called OC Para PS over phone regarding appraising the whole matter and requested to arrange an investigation kit box and also to arrange an Executive magistrate, a videographer and one electronic weigh machine. Thereafter, at about 21:15 Hrs CI Kashipur, Inspector Dipankar Sarkar and OC Para, SI Pankaj Singh along with SI Bhudeb Chandra Kuiry were arrived at the said spot with an investigation

kit box, videographer and electronic weigh machine. Accordingly, I prepared inventory list at the house of the PC accused Sagar Osta at Bamunbaid in between 21:20 hrs and 21:35 hrs. Thereafter, at about 22:05 Hrs I issued a Notice to the PC accused Sagar Osta informing about his legal rights to be searched in presence of a Ld. Magistrate or a Gazetted Officer in presence the independent witnesses as well as I also explained the meaning & terms of Gazetted officer and Magistrate to him. But he refused to go anywhere else and he also opted to be searched on aforesaid spot only. Accordingly, I searched for a Ld. Magistrate in that locality, but failed. Instantly, I apprised them about the facts so far. Then, I also introduced CI Kashipur, Inspector Dipankar Sarkar as Gazetted Officer (G.O.) to the PC accused Sagar Osta.

After that, at about 22:45 Hrs in presence of the Gazetted Officer, issued another Notice upon the PC accused Sagar Osta under provision of NDPS Act and also informed about his legal rights to be searched in presence of a Gazetted Officer. In reply, the PC accused again re-confirmed that he wanted to be searched on the spot only in presence of the Gazetted Officer. He also asked to search the raiding party by the Gazetted Officer, accordingly he searched the raiding police party and found nothing like narcotic drug or psychotropic substances in possession and a NIL search list was prepared.

In presence and under the supervision of CI Kashipur, Inspector Dipankar Sarkar house search process was conducted and during search the PC accused namely Sagar Osta had shown and brought out one 05 lit. transparent plastic Jaricane along with green coloured cap containing light red colour liquid which seemed as contraband codeine mixture. On interrogation, PC accused namely Sagar Osta S/o- Kismat Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia, disclosed and admitted that he was habituated in dealing of such illegal business of Codeine mixture with his associate Tayab Ansary S/o- Late Isak Ansary of Belma, PS-Purulia (M), Dist- Purulia for their wrongful gain, knowing the same is a punishable offence.

On demand he failed to produce any valid documents or justify regarding the storage of hug quantity of contraband codeine mixture. According to the direction of CI Kashipur, Inspector Dipankar Sarkar I weighed 05 lit. transparent plastic Jaricane along with green coloured cap and it resulted in 6 kgs 204 grams including Jaricane in eletronic weighing machine. An offence has been committed in respect of recovered liquid substance codeine mixture from which approx 2 bottles were taken as test sample and security sample. The said articles were seized under proper seizure list duly signed by the witnesses as well as the accused in between 00:05 hrs and 01:15 hrs. No public witness was available there are due the dead hrs of night. Despite of that PC accused is a dangerous criminal, being frightened none turned up as witness I also supplied a copy of seizure list to the accused. The seized articles were properly sealed and labeled in presence of CI Kashipur, Inspector Dipankar Sarkar. An Inventory list was also made after Seizure. The entire process was directly supervised by CI Kashipur, Dipankar Sarkar and video graphed.

Under the above fact and circumstances I am submitting this complain before you for lodging an FIR against the PC accused Sagar Osta S/o- Kismat Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia and his associate Tayab Ansary S/o- Late Isak Ansary of Belma, PS- Purulia (M), Dist- Purulia U/S- 21 (c) /29 of N.D.P.S Act. 1985 as amended up to date and arrange for its investigation.
