Sub-F.I.R against Sri Nimal Bauri and Sri Arun Bauri both ,S/O-Sri Mangal Bauri, Village-Laharia,P.O.-Bhagabandh,P.S.-Pancha, Dist-Purulia ,Pin- 723151 for unauthorized drawal of electricity through direct hooking from the nearest pole of WBSEDCL at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that Sri Nimai Bauri and Sri Arun Bauri both ,S/O-Sri Mangal Bauri , Village-Laharia,P.O.-Bhagabandh,P.S.-Pancha, Dist-Purulia ,Pin- 723151 has committed theft of electricity through direct hooking from the nearest pole of WBSEDCL under section-135 clause (1)(a) of the electricity act subsequently amendment act-2007 on 06.11.2023 at about 2:40P.M.

I Sri Saikat Mallick,S/O-Himadri Mallick,A.E & S.M of Pancha CCC along with 1) Sri Somnath Soren(J.E Gr-I),S/O-Lt. Pannalal Soren, 2)Sristidhar Mahato(Sr. T.S.H),S/O- Lt. Ganesh Mahato, 3)Sri Sandip Mahato(O.E.),S/O-Lt. Brindaban Mahato, and other technical staff attached to Pancha CCC entered the premises of Sri Nimai Bauri and Sri Arun Bauri both ,S/O-Sri Mangal Bauri,Village-Laharia,P.O.-Bhagabandh,P.S.-Pancha, Dist-Purulia ,Pin- 723151 and inspected his premises .During the inspection theft of electricity was detected through direct hooking from the nearest pole of WBSEDCL under section 135(1)(a).

The accused person was consuming electricity dishonestly at his domestic premises through direct hooking from the nearest pole of WBSEDCL causing considerable revenue loss of WBSEDCL ,during inspection total load found was 1.02KW.From the above hooking arrangement system he uses the following electrical equipments-

1) light-01 nos(20 Watt ) 4)01 no electric heater(1000Watt)

The following items were seized from the house of the accused person-

1)Single Core 6sqmm PVC cable approx length 10(Ten)meters 2)Electric heater 01no

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 3:00P.M. On 06.11.2023.The accused person has committed an offence U/S 135 (1)(a) of E.A-2003 subsequently amendment E.A-2007.You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
