I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Bidyasagar Bauri S/O- Lalit Uttam Bauri of Village- Dabas, P.O- Paiachali, P.S.- Puncha, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07.11.2023 at about 03:18 P.M I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Bidyasagar Bauri, S/O- Lalit Uttam Bauri of Village- Dabas, P.O- Paiachali, P.S.- Puncha, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisly by direct hooking from LPOH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)() was detected. It was also found that he/she was using the following electrical equipments -

- 1) One no water cooler
- 2) Two nos Incandescent bulb of 100 watt each.
- 3) Two nos ceiling fan of 60 watt each.
- 4) Four nos LED lamp of 09 watt each.
