Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Swapan Sing Sardar (36 yrs) S/O- Lt. Dasarath Sing Sardar of Vill- Joykalla PS-Puncha , District- Purulia with seizure of 10 Ltr ID Liquor which were seized under proper seizure list. I beg to submit that today (09/11/2023) at 15:45 hrs while myself along with C/2756 Sanjoy Rajowar & HG/1846 Panchanan Mahato vide Puncha PS CC No - 2993/2023 Date 09/11/2023 were performing anticrime mobile duty at Joykalla Village side under Puncha PS .During mobile duty received source information that one Swapan Sing Sardar (36 yrs) S/O- Lt. Dasarath Sing Sardar of Vill- Joykalla PS-Puncha , District- Purulia has illegally stocked ID liquor in the house at Joykalla village under PS-Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Joykalla Village to work out the information. At 15:55 hrs after reaching at Joykalla village held raid in a house of Swapan Sing Sardar (36 yrs) S/O- Lt. Dasarath Sing Sardar of Vill- Joykalla PS-Puncha , District- Purulia and found that the above noted person was keeping / selling ID liquor which were kept in his house, on demand Swapan Sing Sardar failed to produce any valid documentary authority in respect of selling of ID liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and I arrested him U/S-67 BE Act after obtaining all formalities regarding arrest U/S 50/50A Cr.P.C guidelines of Hon'ble Court APEX & NHRC and also seized 10 Ltr ID liquor in a plastic container which were seized under proper seizure list duly signed by witnesses and accd person and 375 ML taken as sample in a plastic bottle are sealed and labeled and handed over a copy of the same to arrestee. I also issued check list U/s-41 (1)(a), (b) (i), (ii) Cr.P.C Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014. Spl. Leave petition.


The arrested accd. Swapan Sing Sardar (36yrs) S/O- Lt. Dasarath Sing Sardar of Vill- Joykalla PS-Puncha , District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of ID liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested person namely Swapan Sing Sardar (36 yrs) S/O- Lt. Dasarath Sing Sardar of Vill- Joykalla PS-Puncha , District- Purulia under proper section of law.
