I Anupam Chand, S/O-Narayan Ch. Chand of Vill. Chandmarldanga, PS- Tamna, Dist Purulia, A/P ASI of Police of Puncha PS,Dist-Purulia do hereby submit complaint against arrested aced persons namely (1) Sk. Neamatulla (34 yrs) S/O Sk Daktar of Vill +PO- Hutmura, PS- Purulia (M), Dist- Purulia (2) Masimuddin Chapak (41 Yrs), S/O Lt. Hikim Chapak of Vill +PO- Hutmura, PS- Purulia (M), Dist- Purulia to the effect that on 17.11.23 during day mobile duty vide Puncha PS GDE No 726 did 17. 11 2023 & CC No 2065 dtd 17.11.23 on Lalpur Manbazar road and today on 17.11.2023 at about: 13.55 hrs I received telephonic information from a reliable source that two vehicle loaded with cattle were coming from Lalpur side without any valid documents or proper permission from concern authority. The matter was intimated to O/C Puncha PS and as per his kind instruction I along with my accompanied force C/ 711 Durgapada Barik & NVF/1043 Sajad Ansary all of Puncha PS rushed to Menidih More on Lalpur Manbazar road I also called officers and force from PS and at about 14.35 hrs I managed to stop the 02 (two) vehicle bearing Registration No WB55B 2359 and WB37C 2660 and found that Total Cattles -25 (twenty five) like Cow-01, Buffalo Calf 22 [twenty two) and Cow Calf 02 (Two) were loaded in the above mentioned vehicles i.e Buffalo Calf 08 & Cow Calf 02 in vehicle No WB 55B 2359 and Buffalo Calf 14 & Cow-01 in vehicle No WB37C-2660.

On being asked, they revealed their identity as noted above but their identity could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicle or the Cattles, and about the procurement of the cattle or vehicle. Not only that they have not any paper regarding transportation of the Cattle etc. The vehicle is not meant for transporting livestock as livestock permit was not available. They did not give satisfactory reason for transporting of Cattles by vehicles. They have stated incoherently and from their statement there is every reason to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accused persons treated the cattle in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth Hence, I seized those Total 25 Cattle and the vehicles noted above from the possessions of the above noted accused persons under proper seizure list and after seizure I also arrested them as they committed offence U/S 379/411/120B IPC and U/S 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accused persons by maintaining all formalities regarding arrest and also issued check list with the help of my accompanied officers and forces. The vehicles are not meant for transporting the cattle also.

I, therefore pray that a case may kindly be started against the arrested accused persons noted above and owner of the those vehicles and others U/S 379/411/120B IPC and U/S 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange in investigation.
