Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Santu Dutta (32 yrs) S/O- Nagen Dutta of Vill- Dhadki, PS-Puncha, Dist-Purulia with seizure of 12 (Twelve) Sealed plastic bottles Country spirit style as "Dil Khush" containing 600 ml. each & 05 (five) Sealed plastic bottles Country spirit style as "BULLET" containing 600 ml. each which were seized and labeled under proper seizure list.

I beg to submit that today (01.11.23) at 17:15 hrs while I SI Abhijit Das along with C/185 Rajesh Roy and HG/1846 Panchanan Mahato both of Puncha PS were performing Spl Mobile Duty vide Puncha PS GDE No-40/23 Dated 01.11.2023 and acting on source information after consulting you at about 17:25 hrs reached at Dhadki more and held raid in the house of Santu Dutta (32 yrs) S/O- Nagen Dutta of Vill- Dhadki, PS-Puncha, Dist-Purulia and found that the above noted person was keeping/selling liquor which were kept in his house at Dhadki on demand Santu Dutta failed to produce any valid document/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents as such he committed offence / 46 A(c)BE Act 1909 so he was arrested on 01.11.23 at 17.35 hrs. U/S 67 BE Act and also 12 (Twelve) Sealed plastic bottles Country spirit style as "Dil Khush" containing 600 ml. each & 05 (five) Sealed plastic bottles Country spirit style as "BULLET" containing 600 ml. each which were seized under proper seizure list duly signed by arrested accused & witnesses and labeled out of which 01 (One) bottle Dil Khush & 01 (One) bottle "BULLET" collected as a sample at the time of seizure During arrest I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee.

The arrested accd person namely Santu Dutta (32 yrs) S/O- Nagen Dutta of Vill- Dhadki, PS-Puncha, Dist-Purulia has committed offense U/S 46A(c) BE Act. 1909 for unauthorized possession and sale of liquor.


Under the above facts and circumstances I therefore pray that a specific case may kindly be started against under proper section of law.


