Sub: Prayer for lodging FIR.

Sir,

In producing herewith the one arrested accused person namely Satyapraksh Paswan @ Tinku (22 Yrs) S/o- Omprakash Paswan of Lodhna 4 No, Kabarsthan, PS-Lodhna, Dist- Dhanbad, Jharkhand, under arrest along with one Blue and white colour vehicle (TATA Dumper) having Registration No- JH 10K 4041, as per number plate fitted with both side of the vehicle under proper seizure list.

I, SI Subrata Sarkar of Purulia (M) PS do hereby lodge this typed complaint against the above noted accused person, to the effect that on 01.11.2023 at 10.25 hrs I received reliable source information from my source that some persons are coming from Lodhna side to Raghunath side after high jacking one vehicle. My source also stated that the persons have obtained the said vehicle by stolen means. Accordingly, I informed the matter to you and as per your kind direction I diarized the fact in GD Book, vide GD Entry No- 67 Dtd. 01.11.2023, and took all informative action. As ordered, I along with C/- 1350 Subodh Kr. Bauri, C/- 2505 Anup Kundu and available forces left for Lipania morh under Purulia (M) PS with a view to start Naka checking duty on Purulia-Barakar Road to verify the veracity of the information and also directed the night RT mobile van party to Lipania for the same purpose.

At 22.45 hrs we, Police party, arrived at Lipania morh and started NAKA checking accompanied by SI Sanjoy Kumar Senapati, C/- 2409 Binayak Dubey & C/-1137 Sridam Bauri, C/- 692 Ukil Ch. Mahato all of Purulia (M) PS. In course of Naka Checking duty in pursuance to the source information received earlier, at about 23.35 hrs, we gave signal to a Raghunathpur bound one Blue and white colour vehicle (TATA Dumper). Seeing the traffic signal given by us, instead of stopping the vehicle in front of us, the driver increased the speed and tried to flee away. Finally, after a hot chase, we managed to detain/intercept one Blue and white colour vehicle (TATA Dumper) having Registration No- JH 10K 4041. On being asked the driver could not able to produce any documents of this vehicle including his driving license. During examination he disclosed his name and identity as Satyapraksh Paswan @ Tinku (22 Yrs) S/o- Omprakash Paswan of Lodhna 4 No, Kabarsthan, PS- Lodhna, Dist-Dhanbad, Jharkhand. The driver failed to give any satisfactory account in respect of the registered owner of the vehicle. Neither could he able to mention the name and parentage of the registered owner, nor the permanent address/phone number of the owner. Hence, it is clear that the driver has obtained the vehicle by stolen or by any fraudulent means and also received/retained the same in his possession with his knowledge and also assisted in concealing/disposing of the vehicle.

Hence, I seized the above descriptive vehicle in presence of the Police witnesses duly signed by them as it was let night no public witness was present. The seizure was made between 23.45 hrs & 23.55 hrs. I also arrested the above noted accused driver

at 00.05 hrs on 02.11.2023 after observing all legal formalities and explaining him the grounds of arrest and took him into custody and make an arrangement to produce the vehicle at PS compound.

Under the above circumstances, I therefore, pray before your good self that a case may kindly be initiated against the arrested accused driver namely Satyapraksh Paswan @ Tinku (22 Yrs) S/o- Omprakash Paswan of Lodhna 4 No, Kabarsthan, PS-Lodhna, Dist- Dhanbad, Jharkhand and others if any under proper section of law.
